

Cage Cleaning/Room Record Keeping

- Found: Cages, chambers not clean, or inadequate documentation of cage care by PI in DCM rooms or in lab. Documentation of room maintenance not recorded.
- Plan: Ensure timely cleaning schedule of cages, equipment or chambers to provide a healthy environment for an animal. Document animal cage cleaning and observations per IACUC policy/DCM SOP/IACUC protocol.
- Reference: "The goal of any sanitation program is to maintain sufficiently clean and dry bedding, adequate air quality, and clean cage surfaces and accessories." Guide p69
 "Whenever possible, routine procedures for maintaining animal should be documented to ensure consistency of management and care." Guide p52

Cleaning

- Found: Area(s) dirty. Countertops, floors, work surfaces, walls with visible dirt or debris, clutter on floor, work areas, mops not hung up, equipment soiled, dirty animal housing.
- Plan: Mop, sweep floors, wiped down all work surfaces. Promptly remove or store items when not in use.

Certification of Equipment /vaporizer, hood

- Plan: Schedule hood or vaporizer certification, discard or replace F/air canisters, implement proper installation and recording of canister use. Please place Do not use on vaporizer until it is calibrated/tested.

Food

- Found: Food out of date, mill date not listed/documented, unlabeled food/treats.
- Plan: Discard any out of date and unwrapped (open) "bricks" of specialized animal diet or feed. Ensure labels and dates are on water bottles. Ensure drinking bottles/sipper tubes are clean and properly installed.
- Reference: "The user should know the date of manufacture and other factors that affect the food's shelf life. Stale food or food transported and stored inappropriately can become deficient in nutrients." Guide p. 66;
 - "Watering devices, such as drinking tubes and automated water delivery systems, should be checked frequently to ensure appropriate maintenance, cleanliness, and operation." Guide p68.

- Plan: Clarify rodent housing meets IACUC Mouse Housing Density requirements or update protocol if nonstandard housing necessary. Separate animals into different or larger housing.
- Reference: "At a minimum, animals must have enough space to express their natural postures and postural adjustments..." Guide p 56. Table 3.2.

- Plan: Ensure work order in place for tank straps, properly document eye wash station, F/air canister monitoring, post certificate, and hazard signs.

- Plan: Modify the IACUC protocol to include a description (justification) of single housing for animals. Ensure all single housing stickers area completed and list current date. Single housed animals have proper enrichment unless approved in IACUC protocol.

 over their environment, which allows them to better cope with environmental stressors..."
