## MISCELLANEOUS.

At the time of inspection it was observed in canine barrier \#6 that eleven dogs were exhibiting abnormal behavior to include spinning and circling. Two females with nursing litters were noticed to be hyper and circling. There is the potential for not only these animals but their puppies as well to be injured. In addition it is possible that these abnormal behaviors indicate behavioral stress of these animals. The facility needs to ensure that behavioral stress and unnecessary discomfort is minimized for all animals.

## ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

*** Two cats (ID\# 11GDAG and ID\# 10HIO6) housed in Barrier \#12 were observed to have a moderate to severe buildup of dental calculi. Dental calculi can lead to health issues and discomfort of the animals. The facility needs to ensure measures are taken to provide adequate preventative dental care to all animals housed at the facility.

## PRIMARY ENCLOSURES.

*** At the time of inspection four enclosures were measured in feline barrier \#12. Two enclosures housed 22 cats, one housed 21 cats, and one housed 19 cats, and each enclosure measured 50 sq ft . Each cat with a weight of less than 8.8 lbs requires 3 sq feet minimum. Respectively the enclosures at minimum for space requirements should measure 66,63 , and 57 sq feet, or the enclosures need to house at maximum 16 cats weighing less than 8.8 lbs. The facility must ensure that animals are provided with the proper amount of space under regulation. This item is being addressed with renovations.

*** At the time of inspection there was an accumulation of dust observed in the medicine cabinet in Room 601 in Building 6. There was an assortment of medical supplies and medications being stored in this area. Facilities where medications and drugs are stored must be kept in a sanitary manner in order to comply with good husbandry practices.

In addition the door leading to the canine kennel area is beginning to rust and corrode. Premises must be kept in good repair to protect the animals from injury and order to comply with good husbandry practices.
*********Correct by May 14, 2015
