Dear Dr. Wirtz,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your June 25, 2018 letter reporting an adverse event at Johns Hopkins University, following up on an initial December 14, 2017 telephone notification. According to the information provided, OLAW understands that a marmoset accidentally died from blunt force trauma to the neck and aspiration of blood. Apparently, a relatively new caretaker panicked when he observed the animal trying to leave the cage and he inadvertently closed the door while the animal was in the doorway thereby injuring the animal. The incident was immediately reported to the Supervisor and the veterinarian promptly examined the animal but was unable to resuscitate the marmoset.

The corrective actions consisted of revising the Standard Operating Procedure for "Marmoset Husbandry and Maintenance" and employing new training for all personnel involved in marmoset care, with an emphasis on keeping calm and contacting the Supervisor for assistance in the safe return of an escaped marmoset.

The establishment and application of policies and practices that are consistent with the provisions of the PHS Policy on Humane Care and Use of Laboratory Animals at Johns Hopkins University are commendable and avoid the perception of a double standard. We appreciate having been informed about this matter and find no cause for further action by this Office.

Dear Dr. Morse:

I am writing to follow up on the telephone report made by Dr. Nancy Ator, Chair of the Johns Hopkins University Animal Care and Use Committee (ACUC), to you on December 13, 2017. A young marmoset was killed when the cage door was closed on his neck.

Review of the situation suggested that the caretaker, who was a newer member of the staff, may have panicked when the animal, which was housed in a stable family group, came to the door and started to leave the cage. In response, the caretaker closed the door quickly, while the monkey was in the doorway, causing trauma to the neck. The caretaker reported the accident to his supervisor immediately, and a veterinarian examined the animal promptly but the marmoset could not be revived. Necropsy revealed hemorrhage in the muscles of the neck but no fracture. The cause of death was concluded to be accidental trauma to the neck and aspiration of blood.

In response to this disturbing event, a senior clinical veterinarian, who had been actively involved in the management of the marmoset colony, revised the Standard Operating Procedure (SOP) for "Marmoset Husbandry and Maintenance," and implemented new training sessions with all staff who would care for these animals. In particular, she stressed in the SOP and in training sessions that staff should not be alarmed if a marmoset was leaving the cage, nor try to catch the animal alone, but rather should contact the Supervisor by phone for assistance in safely returning a marmoset to the home cage to avoid injury to the marmoset. Follow up by the ACUC Senior Training and Compliance Specialist over the months since this incident has not revealed further problems with handling of the marmosets.
