Dear Dr. O'Byrne,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your April 3, 2018 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Wake Forest University. According to the information provided, OLAW understands that a mouse was left in a flooded cage in the dirty side of the cage wash. The animal had inadvertently been left in the cage after it was changed.

The immediate action taken upon discovery consisted of euthanizing the mouse. The corrective actions consisted of counseling the Principal Investigator and animal caretaker, observing the caretaker's cage changing technique, and issuing a Notification of Correction Action Letter to the Animal Resources Program.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy.

The Wake Forest University Animal Care & Use Program experienced a deviation from standard procedure that was determined by the Wake Forest University (WFU) Institutional Animal Care and Use Committee (IACUC) to be reportable to the NIH Office of Laboratory Animal Welfare.

PHS funding

If appropriate, we will forward to our sponsored research office and all direct costs associated with the procurement, care and use of the animal(s) involved in this noncompliance event will be removed from this account and invoiced to and paid from a nonfederal source.

Incident

A mouse was found in a cage that had been flooded and placed in the dirty side of the cagewash. The mouse was inadvertently left in the flooded cage when it was changed out. There was no identifier present for the mouse and since it had been placed in an area of potential contamination, it was humanely euthanized.

Preliminary Report

No preliminary report was made to OLAW.

Resolution

The WFU IACUC contacted the Principal Investigator and discussed current Institutional policies and regulatory compliance related to this concern. The IACUC approved the following actions to resolve this incident:

1. The care staff person was counseled on proper cage changing techniques and was observed as part of the training process.
2. A Notification of Correction Action Letter was sent to the Animal Resources Program.

All actions have been completed/implemented at this time and the WFU IACUC considers this non-compliance matter closed. The program oversight staff will continue to monitor animal care and use procedures to assure compliance with IACUC approved processes.
