Dear Dr. Orf,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your January 31, 2020 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the Massachusetts General Hospital. According to the information provided, OLAW understands that on October 15, 2019 it was found that five mice had be improperly euthanized using CO2. A research staff member left the building during the procedure and a building staff member found the animals and completed the euthanasia. It was stated that the animal activity was not supported by PHS or NSF funds.

Corrective actions included The PI counseling the research group regarding proper euthanasia technique and responsibilities and focused on the correct procedures at the next laboratory meeting.

OLAW believes that the corrective measures put in place by the Massachusetts General Hospital are consistent with the provisions of the PHS Policy on Humane Care and Use of Laboratory Animals regarding the philosophy of institutional self-assessment, self-reporting and self-regulation. Although this activity was not PHS funded, the application of the expectations of the PHS Policy across the animal care and use program reduces any potential appearance of a double standard. We appreciate being informed of this matter and find no cause for further action by this office at this time.

Dear Dr. Morse:

This letter is to provide you with a full explanation of the circumstances and actions taken by the Massachusetts General Hospital (MGH) Institutional Animal Care and Use Committee (IACUC) as required by Public Health Service Policy on Humane Care and Use of Laboratory Animals (PHS Policy) Section IV.F.3 following an incident that occurred. The incident was determined by the IACUC to constitute serious noncompliance with PHS Policy and is therefore reportable.

The incident occurred on October 14 and involved the euthanasia of 5 mice that was not conducted in accordance with institutional policy. The animals were euthanized by carbon dioxide overdose. The responsible scientist exposed the mice to the gas and then left the facility. IACUC policy requires that animals not be left unattended during euthanasia and death must be confirmed. A facility staff member found the mice and completed the euthanasia procedure. Because there were no identifiers on the cage an investigation was initiated to identify the responsible party. The PI and the lab's research assistant met with the IACUC compliance officer and the facility veterinarian on November 26 to review the incident. A compliance subcommittee of the IACUC reviewed the event on December 5 and the convened IACUC reviewed the event at its monthly meeting on December 18.

The PI retrained the research staff on the IACUC Policy on Euthanasia and counseled the group on appropriate procedure and responsibility when performing euthanasia. The PI communicated to the team by email immediately after the event and focused on correct procedure at the next laboratory meeting on December 5. The IACUC approved this corrective action.

No PHS/NSF funds were implicated in this matter.
