VII. Animal Care and Use Program Changes

Since the last OLAW Annual Report, the following changes have occurred in the institution's program for animal care and use:

The AV in collaboration with the Vivarium Staff updated the PPE requirements to decrease the use of shoe covers in the vivarium and animal rooms. The PPE SOP has since been updated.

The IACUC Acclimation, Procurement and Transfers Policy was updated to include procedures for protocol transfers from outside Atrium.

The AVMA Guidelines for Euthanasia was updated for 2020 (last update was 2013). All euthanasia policies and SOPs have been updated to reflect any changes.

The entire research department is now accepting email approvals if a wet signature is not obtainable during the pandemic.

The vivarium now employs two(2) Animal Care Technician (ACT) level II techs versus one(1)ACT level II and one(1) ACT level III tech.
