Dear Ms. Dickens-Ray,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your December 22, 2020 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Oklahoma-Norman following up on an initial December 11, 2020 notification by telephone.

According to the information provided, this Office understands that the University of Oklahoma-Norman Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to: the conduct of animal-related activities without appropriate IACUC review and approval. The final report states in June 2019, a graduate student captured fish from an Oklahoma lake and held them in aquaria for ~8wk to study chemical influences on invertebrate species. The procedures were repeated from another Oklahoma lake in May 2020. There were no reports of morbidity or mortality (per the report), and each fish was released back into its native environment following completion of the study.

On November 25, 2020, the student contacted the IACUC to request a copy of an approval letter for these activities. It was determined that no requests to review such activities had ever been received. The principal investigator (PI) reported working on a draft animal protocol for the proposed animal activities but failed to submit the protocol for IACUC review. The PI took responsibility for the noncompliance. During the committee meeting on December 2, 2020, the IACUC reviewed the matter and determined the incident reportable to OLAW. The following processes are already in place to prevent recurrence:

- The University's requirement that all research or teaching involving live vertebrate animals be reviewed and approved by the IACUC prior to initiation of those activities is prominently posted in the Graduate College Bulletin for students and faculty mentors.
- All faculty, students, and staff of the University working in research must complete required training on IACUC expectations and animal safety.
- All personnel planning to work with animals at the University are required to complete online training which describes both IACUC and investigator responsibilities when working with animals and important aspects of the protocol review process.
- Incoming graduate students are required to attend a departmental lecture each fall in which a
  member of the IACUC presents an overview of IACUC expectations and requirements for
  working with animals at the University.

The report further states the IACUC accepted the PI's commitment to seek IACUC approval. It is noted that this study is not supported by PHS funds. Based on its assessment of this explanation, OLAW understands that the University of Oklahoma-Norman has implemented appropriate measures to correct and prevent recurrences of these problems and is now compliant with provisions of the PHS Policy. We appreciate being informed of these matters and find no cause for further action by this Office.

Dear Dr. Morse:

The University of Oklahoma, in accordance with Assurance D16-00153 and PHS Policy IV.F.3., provides this report of noncompliance regarding an incident that my designee reported to you on December 11, 2020, involving a non-PHS funded study. The University's final report is as follows:

Beginning in June 2019, a graduate student captured fish from an Oklahoma lake and held them in aquaria for approximately eight weeks to study chemical influences on invertebrate species. The procedures were repeated with fish from another Oklahoma lake beginning in May 2020. None of the animals reportedly experienced morbidity or mortality, and each animal was released back into its native environment following the completion of the study period.

On November 25, 2020, the graduate student contacted the IACUC to request a copy of an approval letter for these activities. After an exhaustive search, the staff assistant for the IACUC confirmed that no requests to review such activities had ever been received. The Principal Investigator mentoring the graduate student reported working on a draft animal protocol in the spring of 2019 which captured the proposed animal activities, but ultimately failed to submit the protocol for IACUC review.

The Principal Investigator expressed to the IACUC Chair that this was an unfortunate incident, took responsibility for the noncompliance, and assured the IACUC that an incident of such nature would not occur again.

During its general Committee meeting on December 2, 2020, the IACUC reviewed a summary of the events and decided to report the incident to OLAW. The IACUC acknowledged that the following resources are already in place to prevent such an incident from occurring:

- 1) The University's requirement that all research or teaching involving live vertebrate animals be reviewed and approved by the IACUC prior to initiation of those activities is prominently posted in the Graduate College Bulletin for students and faculty mentors.
- 2) All faculty, students, and staff of the University working in research must complete required training on IACUC expectations and animal safety. This training is delivered by the Environmental Health and Safety Office and must be completed annually.
- 3) All personnel planning to work with animals at the University are required to complete online training which describes both IACUC and investigator responsibilities when working with animals and important aspects of the protocol review process. This training is hosted through the AALAS

4) Incoming graduate students are required to attend a departmental lecture each fall in which a member of the IACUC presents an overview of IACUC expectations and requirements for working with animals at the University.

The IACUC accepted the Principal Investigator's commitment to seek IACUC approval before working with vertebrate animals in the future. The Committee then determined that this was an isolated incident and not a programmatic failure. Because the study concluded in August 2020, the Investigator does not plan to submit a protocol for IACUC review that pertains to this incident.

The University is committed to protecting the welfare of animals used in research and appreciate the guidance and assistance provided by OLAW in this regard.
