Ad hoc inspection of the Barn was performed. After some time being unused, it has had some repairs made and is planned to be used in late October. Feeder dividers are new, and the north entrance was repaired and new door attachments installed. Two minor deficiencies were noted.

Minor - The south door, east side has a glass window, but the surrounding structure has deteriorated to the extent that it does not support the glass.

Inspection Summary: As suggested from the last inspection, a training on euthanasia was provided for all of the farm staff, specifically on the captive bolt gun. Records were in good order. There was a good plan in place for pasture management and rotational grazing. The organizational plans that were underway last year have been implemented. Communication between the manager and farm staff appears to be very good. Research projects and upcoming animal movements and herd processing plans were clear and well organized. All medications were in date. Medical records were documented appropriately. Herd size has decreased with the culling of non-productive animals. Cows and calves appeared to be in good health and adequate body condition. Plans are being made for winter feeding strategies. The hospital pens were empty. No deficiencies were noted.

Inspection Summary: New mill will be inspected in mid-Novermber.

Inspection Date: 9/25/2020

Inspection Summary: No animals were housed at the facility at the time of inspection. Facility is clean and in good repair. There are plans to reconfigure some pens for larger group sizes. No deficiencies were noted.

Inspection Date: 9/11/2020

Inspection Summary: Horses appeared in good condition. Fences on south end of the farm have had boards replaced with pipe. Medical and daily care records were complete. The Barn stalls appear to be in good repair. Farm staff was able to cope with reduced labor availability due to COVID-19 by moving most of the animals off site temporarily and using technology for foal watches. Manager reports that pastures with problematic waterers due to electrical issues will not be used over winter. The manager reported during the last inspection (2/26/20) that the Barn was not being used for housing any more. During this inspection, two mares and their foals were being housed in the west side stalls. Those stalls seemed to have adequate structural integrity from a non-expert examination, but it is known from previous visits that some stall walls were in poor condition and must not be used. One deficiency was noted.

Deficiency:

Minor - Barn - Some stalls were not fit for use due to poor wall integrity during last inspection.

Correction: Place signage on the SE stalls indicating that no animals should be housed there.
