During the evaluation of our animal program, some animals were found to fit the Category E classification after evaluation of the experimental procedures. We found that 40 guinea pigs subjected to the positive controls, as required by ISO and USP regulations [REDACTED] b4

Additionally, we found 6 rabbits to fit the Category E criteria. These rabbits were unexpectedly found dead during routine health checks and were from unrelated studies.
