Dear Dr. Rodríguez-Quilichini,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your March 28, 2018 letter reporting an adverse event at the University of Puerto Rico Medical Sciences Campus. According to the information provided, OLAW understands that the lid to one of the water tanks was removed and a juvenile rhesus macaque accidentally fell into the tank and drowned.

The corrective actions consisted of immediately removing the animal, sanitizing the tank and securing the tank lid with a padlock. In addition, all water tanks around the island were checked to ensure that the lids were secured with a padlock.

The establishment and application of policies and practices that are consistent with the provisions of the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Puerto Rico Medical Sciences Campus are commendable and avoid the perception of a double standard. We appreciate having been informed about this matter and find no cause for further action by this Office.

Dear Dr. Wolff:

This is to report an adverse incident at the Caribbean Primate Research Center, Cayo Santiago Field Station., Medical Sciences Campus, University of Puerto Rico. The incident resulted in one animal death. The event was identified on March 14, 2018, reported to IACUC by phone on March 15, 2018. The written report was submitted on March 20.

One employee noticed the lid of one of the water tanks that supplies water to the drinking troughs around the island was removed. Immediately personnel started restoring the lid in place, but noticed one juvenile rhesus female (ID 1X5 from Group P) had, unfortunately, fall inside the tank and accidentally drowned.

The animal was removed immediately, the tank was emptied, sanitized and refilled with water. The tank lid was placed and secured with a padlock.

To prevent future incidents like this, all the water tanks around the island were verified to be certain all haves their lids secured with a padlock.


