Dear Dr. Evans,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your December 9, 2020 letter reporting two instances of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Weill Cornell Medical College. According to the information provided, OLAW understands the following about the incidents and the corresponding corrective actions:

 Four live research mice were found in the carcass refrigerator after being exposed to a reduced CO2 flow caused by a faulty gas line in the euthanasia chamber. The mice had been subjected to cervical dislocation following CO2 exposure but death was not confirmed.

Corrective action: The CO2 line was fixed and the veterinary technician responsible was counseled and retrained on cervical dislocation and verification of death.

2) Two adult mice were subjected to unapproved toe clipping. The procedure was not approved in the protocol and was prohibited by institutional policy.

Corrective action: The mice were euthanized and the laboratory staff was counseled to read the protocol and only perform approved procedures.

Based on its assessment of these explanations, OLAW understands that measures have been implemented in both situations to correct and prevent recurrence of the problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy.

Dear Dr. Morse:

We are writing to report incidents of non-compliance that occurred within the animal care and use program at Weill Cornell Medicine. The incidents were presented to and discussed by the IACUC during the month of December. The incident and resolution is as follows:

Four moribund mice were euthanized with CO_2 followed by cervical dislocation. They were placed in a refrigerator prior to a scheduled post-mortem evaluation. When the mice were removed, approximately 15 minutes later, the mice were found alive. Upon inspection, an issue was found with the CO_2 line resulting in reduced CO_2 flow. The veterinary technician that performed the euthanasia was counseled and retrained on cervical dislocation and verification of death and the CO_2 line was corrected.

Two adult mice underwent toe clipping for identification and were observed shortly afterwards. The procedure was not described in the protocol and is not permitted in adult mice. The mice were immediately euthanized as requested by Veterinary Services. The IACUC contacted the PI and had her meet with her lab members reminding them of the need to carefully read the protocol, be aware of which procedures are approved and to only perform approved procedures as described.
