 - c. A quorum of the IACUC is defined as a majority of the total current membership. In order for official IACUC business to be conducted, a quorum must be present.
 - d. Pursuant to PHS Policy Section IV.C.2, no member may participate in the IACUC approval of an application, proposal, or any animal use protocol, in which the member has a conflicting interest (e.g., is personally involved in the project), except to provide information requested by the IACUC; nor may a member who has a conflicting interest contribute to the constitution of a quorum.
 - In the case of a Full Committee Review, as defined in Section IV F. herein, member(s) with a conflict of interest shall not be permitted to vote, nor be counted toward a quorum.
