Dear Ms. McGill,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your March 1 and May 29, 2019 letters reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Lifespan/Rhode Island Hospital. According to the information provided, OLAW understands that mice were being bred and produced offspring in numbers greater than what had been described in the approved protocol. The Principal Investigator (PI) failed to submit an amendment to increase animal numbers and did not indicate how the animals were being used.

The corrective action consisted of the Institutional Animal Care and Use Committee (IACUC) chair revoking the PI's access to the animals and directing separation of the breeding pairs. The IACUC suspended the study and required an explanation on the disposition of the mice. The PI attended an IACUC meeting, was retrained, provided a written explanation regarding disposition of the mice, and submitted a new protocol. The laboratory was placed on enhanced post-approval monitoring.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the IACUC to comply with the PHS Policy.

Dear Dr. Morse,

I am writing to provide a follow-up to the IACUC imposed suspension which we initially reported on March 1, 2019.

Briefly, the incident involved breeding of mice beyond numbers that were originally approved by the IACUC (272 approved, 462 used), and failure of the PI to communicate with the animal facility and IACUC administrative staff. The project was placed on hold by the IACUC Chair on February 19, 2019, and the protocol was formally suspended by a vote of the full board at its regularly scheduled meeting on February 27, 2019. At that meeting the IACUC requested from the PI an explanation for the disposition of all of the animals used on his protocol, and an amendment to revise the animal numbers for the project. The study was wholly supported with internal funds.

The Principal Investigator met with the IACUC Chair to review the incident and provide refresher training regarding the IACUC's expectations and requirements. The Principal Investigator subsequently provided a written explanation as to the disposition of the animals, and he appeared in person at the IACUC meeting on May 22, 2019. The investigator accepted full responsibility for poor management of the breeding colony and for failure to respond to requests from administrative staff.

The IACUC accepted the PI's response and voted to lift the suspension. However, IACUC approval for the initial study has since expired and a de novo application will be required to continue the work. As a stipulation for lifting the suspension the IACUC members agreed that more frequent oversight will be required for any new submissions from this investigator (mandatory, frequent PAMS) and there will be a low threshold for IACUC intervention for any future infractions.



Dear Dr. Morse,

I am writing to inform you of a recent incident of non-compliance with PHS Policy on the Humane Care and Use of Laboratory Animals that occurred at our institution. The work is wholly supported with internal funds.

The incident involved breeding of mice beyond numbers that were originally approved by the IACUC. Despite repeated requests for clarification by animal facility and IACUC administrative staff, the Principal Investigator did not provide a clear description of how the animals were used and did not submit a request for additional animals. The IACUC Chair was advised of the situation and he immediately placed a hold on the work, which involved revoking access to the animals and separation of breeding pairs, until the matter could be reviewed at a convened meeting of the full IACUC.

The incident was discussed at the regularly scheduled meeting of the full IACUC on February 27, 2019, at which time the members voted to suspend the study until they received: 1) a suitable explanation for the disposition of the extra animals, and 2) an amendment to revise the animal numbers for the project. The PI has submitted a revision request for more animals, but it was not received until after the IACUC met on February 27. This request will be reviewed at the next IACUC meeting, which will be held on March 27, 2019.

We will provide a follow-up report to you after the suspension is lifted by the IACUC.
