Dear Ms. McGill,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your September 3, 2019 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Rhode Island Hospital. According to the information provided, OLAW understands that 12 mice were subjected to surgery two days after arrival, although the institutional policy states that all animals must be acclimated for three days before conducting procedures. Furthermore, the surgical procedure had not been included in the protocol.

The corrective action consisted of retraining the research staff on the acclimation policy and amending the protocol to include the surgery.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy.



RE: Animal Welfare Incident at Rhode Island Hospital (Institutional Assurance No: A3922-01)

Dear Dr. Morse,

I am writing to inform you of an incident of non-compliance with PHS Policy on the Humane Care and Use of Laboratory Animals at our institution. The incident was associated with work supported with internal funding.

Briefly, survival surgery was performed on 12 pregnant mice two days after arrival at RIH, earlier than the institution-mandated minimum 3-day acclimation period. Additionally, the surgical procedure was not included in the currently approved protocol. The procedure had been approved as part of the original protocol, but it was inadvertently omitted in the recent de novo submission.

The researchers self-reported the unapproved surgical procedure error, took full responsibility and were very cooperative as the incident was investigated. Refresher training was provided regarding the importance of acclimation, and an amendment was submitted and approved to add the surgical procedure back onto the protocol.

The IACUC reviewed the matter and accepted the corrective action plan at its regularly scheduled meeting on 8/28/2019.
