Dear Dr. Westergaard,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your May 31 2017 letter responding to our May 25th request for additional information regarding the death of a PHS-supported animal at Alpha Genesis, Inc. From the additional information provided OLAW understands that the animal that reached through her enclosure and grabbed a partially buried extension cord was supported by contract number HHSN272201000051C and that the funding component has been notified of the April 22, 2017 incident. The cord was contained within a PVC pipe buried outside the enclosure and it is not clear how the animal accessed the cord and pulled it into the enclosure. The cord was used to power temporary heaters and all such cords have been collected and stored.

OLAW appreciates the consideration of this matter by Alpha Genesis, Inc. which was consistent with the philosophy of institutional self-regulation. Based on the additional information provided, OLAW is satisfied that appropriate actions have been taken to address the current issue. In order to prevent recurrence OLAW would expect your institution to consider all options available regarding securing the electrical cords from access by the animals. We appreciate the additional information regarding this matter and find no cause for further action by this office at this time.

Dear Dr. Morse,

This letter is in response to the letter received from OLAW dated 5/25/17 regarding Animal Welfare Assurance #A3645-01 Case W.

The PHS-supported animal was found dead on 4/22/17. The contract number that supported the animal is HHSN272201000051C. The funding component has been notified. The extension cord was buried in a location adjacent to the enclosure to provide electricity to temporary heaters we provide to the animals for warming during the winter months. The cords are buried in a PVC pipe to prevent the animals from accessing the cords. The cord was not in use or plugged in at the time (i.e. was not conveying electricity) and all similar cords have been collected and stored for the spring/summer/fall. The animal was somehow able to access the cord and pull it into the enclosure despite it being buried outside the enclosure.

Dear Dr. Westergaard,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your May 16, 2017 letter reporting two accidents involving juvenile *Macaca mulatta* within the animal care and use program at Alpha Genesis, Inc. From the information provided OLAW understands that in the first incident the animal reached through its enclosure and grabbed a dislodged cable that opened and closed a chute door. The animal was found dead. A clear cause of death was not determined. To correct and prevent this issue, a facility-wide inspection was conducted to ensure no other such cables remained within reach of any animals. This animal was not NIH funded.

In the other incident the animal reached through her enclosure and grabbed a partially buried extension cord. The cord was not plugged in and not in use. The animal was found dead. A clear cause of death was not determined. To correct and prevent this issue, all similar areas were checked and buried cords within reach of animal enclosures were removed. This animal was PHS funded.

OLAW believes that the corrective and preventive measures by Alpha Genesis, Inc. are consistent with the provisions of the PHS Policy on Humane Care and Use of Laboratory Animals for institutional self-monitoring and self-reporting. Regarding the animal that was PHS-supported, please provide the date that the animal was found dead and the grant or contract number that supported the animal. Has the funding component been notified of the incident? Please also provide additional explanation for why an extension cord was buried in this location. Was the cord found within the enclosure? We appreciate being informed of these matters and **request your reply to this office by June 5, 2017**.

Dear Director,

This self-report describes two accidents that occurred on 4/16/2017 and 4/22/2017. AGI IACUC conducted an immediate investigation of the incidents and has concluded that it is an issue that should be self-reported to OLAW. These accidents affected one PHS supported animal and one non-PHS supported animal.

Both accidents involved juvenile *Macaca Mulatta*. The non-PHS supported animal reached through its enclosure and grabbed on to a cable that opened and closed a chute door. It is suspected the cord became dislodged during a wind storm the prior evening. The animal was found dead. Gross necropsy and histopathology results showed no clear cause of death although it is possible that the cable was involved. Corrective actions included a facility wide inspection to ensure no other such door access cables remained within reach of any animals.

The other accident concerning the PHS supported animal involved the animal reaching out of her home enclosure to access a partially buried extension cord. The cord was not plugged in and was not in use. The animal was found dead. Gross necropsy and histopathology results showed no clear cause of death though it is possible the cord was involved. Corrective actions for this accident include checking all similar areas and removing buried cords within reach of animal enclosures.
