Dear Dr. Creamer-Hente,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your October 17, 2018 letter reporting an adverse event involving a pig at Synchrony Labs. According to the information provided, OLAW understands that a pig had its rear leg trapped in a gap between the wall panel and floor.

The immediate action taken upon discovery consisted of sedating the animal and freeing the leg. The animal was euthanized while sedated, in accordance with the protocol. All wall panels will be replaced with chain link fencing which meets the floor without gaps. The repairs are expected to be finalized by December 2018 and any gaps identified in the interim will be filled.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy on Humane Care and Use of Laboratory Animals. Please remember to have all final reports signed by the Institutional Official. Thank you for informing OLAW about this matter.

We would like to inform you of an unexpected adverse event that took place at Synchrony Labs, Assurance **#**: A4628-01

On Tuesday evening, October 16, 2018 a farm pig was found with its right hind foot caught between the cage's stainless steel wall panel and the grated flooring. The Attending Veterinarian was notified Immediately and the animal was heavily sedated prior to freeing the limb. The Study Director and Institutional Official were promptly notified on 10/16/18 via phone and follow-up email regarding the incident. The animal was scheduled for euthanasia per the protocol on 10/16/18 and euthanasia was performed following sedation.

Upon inspection of the cage, a very small gap was present between the flooring and the stainless steel paneling however no other obvious defects in the paneling or flooring were noted. Veterinary recommendations to assess all caging and replace any stainless steel paneling with an alternative product were approved by the Institutional Official. The Institutional Official immediately allocated resources to address the cage paneling. Cage modifications to replace stainless steel paneling with chain link fencing that extends to the cage floor without any gaps has begun on 10/17/18. The expected time to complete the modification of all remaining cages with stainless steel paneling is December 15, 2018. In the interim, any gaps in the stainless steel to flooring will be temporarily modified with material that will prohibit the potential for an incident of this nature from happening again while the permanent modifications are being done.

Synchrony Labs is committed to providing high quality animal care and will continue to assess the facility for any additional structural improvements that are needed. Please let us know if you have any further questions, concerns, or recommendations.
