Dear Mr. Mason,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your November 6, 2019 letter regarding noncompliance with the Public Health Service (PHS) Policy on Humane Care and Use of Laboratory Animals at the Beth Israel Deaconess Medical Center. Your letter was preceded by a preliminary report to OLAW by telephone on September 23, 2019. According to the information supplied, OLAW understands that 25 lamprey larvae died on September 18, 2019 from the inadvertent addition of bleach to their tank. Earlier that day, during routine cleaning procedures, the facility supervisor failed to label a carboy that was filled with bleach in a room housing lamprey. Later, a researcher added the contents of the carboy to the tank of lamprey larvae unaware that it contained bleach and not water. The lamprey larvae died immediately, and the researcher reported the deaths to her supervisor who contacted the facility supervisor. After the facility supervisor went to the tank room, she determined what happened and self-reported the incident on September 19, 2019. The animal activity was reported to be PHS supported in the preliminary report, and your letter indicated that the per diems were covered by departmental funds.

Corrective actions included the Principal Investigator discussing the incident and indicating that use of cleaners was unnecessary and autoclaving on a regular schedule was sufficient. Additionally, the facility manager submitted an SOP for lamprey husbandry that described autoclaving all carboys at least once per month and discontinuing use of all cleaners and bleach. The SOP was reviewed and approved by the IACUC, and the animal care staff were trained on the SOP.

OLAW accepts the corrective actions to prevent recurrence of this noncompliance and concurs with the actions taken by the institution to comply with the PHS Policy. We appreciate being informed of these matters and find no cause for further action by this Office at this time.

No attempts were made to revive the lamprey larvae as they were clearly dead, indicated by complete lack of movement, and no reaction to physical stimulation. It is unclear where the miscommunication occurred.

On September 25th, 2019, a letter was sent from the IACUC to the Animal Facility Manager, and copied to the Research North Facility Supervisor, the Researcher, the Researcher's Supervisor and the Principal Investigator. This letter requested a response within 5 days of receipt with a plan going forward to prevent it from happening again.

On September 30th, 2019, the Principal Investigator responded with a letter stating that the incident was discussed and that using cleaners such as bleach to prevent pathogens from growing in the water was unnecessary and that utilizing a regular schedule of autoclaving would be sufficient.

On October 2nd, 2019, the Animal Facility Manager responded with a letter to the IACUC and submitted SOP C19-062: Animal Husbandry Direct Care: Sea Lamprey Larvae for discussion at the October 3rd, 2019 IACUC meeting and the SOP was found to require minor modifications. The Research North Animal Care Staff have been trained on the newly revised SOP and the Animal Facility has instituted the practice of autoclaving all carboys inside the facilities at least once per month and discontinuing the use of all cleaners and bleach. The minor edits to the newly revised SOP have been reviewed via IACUC designated member review and approved.
