Dear Dr. Szabo,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your February 9, 2021 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the Beth Israel Deaconess Medical Center, Inc. following up on an initial February 8, 2021 notification by voicemail.

According to the information provided, this Office understands that the Beth Israel Deaconess Medical Center Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to: two mice presumed dead after discovery in a flooded cage. The final report states on January 29, 2021 a Lab Animal Technician II removed a flooded cage from a barrier facility and disposed of the animals in a plastic bag and placed it in a carcass refrigerator. Less than an hour later, an Animal Research Facility (ARF) staff member noticed a mouse moving inside the bag. In response, an ARF Supervisor was alerted and provided supportive care to the animal, that resulted in its fully recovery.

On February 1, 2021, the ARF Director notified the IACUC of the matter. The animal technician responsible for the incident acknowledged they failed to inform their supervisor of the matter, which is standard procedure. As a result, the technician was removed from participating in animal handling duties until the IACUC reviewed the incident. On February 4, 2021, the incident was discussed at the IACUC meeting and the committee approved creation of an SOP written by the ARF Director and Associate Director that includes the following information:

- Clear steps to take should mice be found in a flooded cage.
- Ensure staff are trained on the SOP and to alert their Supervisor immediately after identifying a flooded cage.
- The Supervisor or a Veterinary Technologist will immediately assess and tend to the animals
 including gentle hand stimulation, drying off with a towel and placing the animal on a controlled,
 heated surface.
- Confirming death by checking for a heartbeat and respiration before placing the animal in the refrigerator.

It is noted that the final report did not include the funding source involving the incident. In the future, please include the source of funding and provide grant numbers for all PHS, NSF or NASA supported work.

Based on its assessment of this explanation, OLAW understands that the Beth Israel Deaconess Medical Center, Inc. has implemented appropriate measures to correct and prevent recurrences of these problems and is now compliant with provisions of the PHS Policy.

We appreciate being informed of these matters and find no cause for further action by this Office.

Re: Non-compliance on Beth Israel Deaconess Medical Center (BIDMC) protocol # 017-2020 titled "Adipocyte gene expression and physiology." This study uses mice.

Dear Dr. Wolff:

We are reporting an animal welfare incident that occurred on January 29, 2021 involving a flooded cage. Two presumed dead mice were found by a Lab Animal Technician II and removed from the flooded cage in the Center for Life Science barrier facility at approximately 7:10 am. The mice were placed in a clear plastic bag and put into the carcass refrigerator, along with a copy of the ARF Notification slip used to email the researchers. Approximately fifty minutes later, a different Animal Research Facility (ARF) staff member noticed one of the mice moving inside the bag inside the refrigerator. The staff member alerted one of the ARF Supervisors who then dried the mouse with a towel and placed it in a heated incubator. The mouse recovered by 12 PM and was responsive and survived. The Principal Investigator was also notified.

On Monday, February 1, 2021, the ARF Director reported the incident to the IACUC using the Beth Israel Deaconess Medical Center IACUC Unanticipated Outcomes Form, which included information from the Animal Technician responsible for placing the animals in the refrigerator. He stated that both mice were cold and stiff and assumed that they both had died of hypothermia and acknowledged that he failed to notify his Supervisor of the incident when it occurred, which is standard procedure. The technician was immediately removed from participating in animal handling duties until the IACUC had discussed the incident.

On Thursday, February 4-2021, the incident was discussed at the monthly IACUC Meeting and the corrective action that committee approved involved creating an SOP written by the ARF Director and Associate Director that includes the following:

1.) Clear steps to take should mice be found in a flooded cage.

2.) Ensure staff are trained on the SOP and to alert their Supervisor immediately after identifying a flooded cage.

3.) The Supervisor or a Veterinary Technologist will immediately assess and tend to the animals including gentle hand stimulation, drying off with a towel and placing the animal on a controlled, heated surface.

We believe these corrective actions will effectively prevent another similar occurrence.


