Re: Terminate and/or deny the renewal of dealer licenses issued to companies that have long histories of failing to comply with the minimum provisions of the federal Animal Welfare Act

Dear Secretary:

I'm writing to request that the U.S. Department of Agriculture terminate and/or deny the renewal of dealer licenses issued to companies that have long histories of failing to comply with the minimum provisions of the federal Animal Welfare Act.

In particular, I'm concerned about the serious and chronic mistreatment of vulnerable animals at Moulton Chinchilla Ranch, Oak Hill Genetics, Ruby Fur Farm, and Oakwood Research Facility, as documented in inspection reports, photographs, and video recordings by your own inspectors.

These facilities breed and warehouse animals in unsanitary, often putrid and abhorrent conditions—allowing sick and injured animals to suffer without veterinary care—before they are sold to laboratories to be tormented in experiments and ultimately killed.

The failure of these companies to comply with the minimum standards signals a disinterest in ensuring animal welfare and a contempt for legally mandated regulations.
