- I. **Findings from Semiannual Facilities Inspection held on 11/4/2020 and Program Evaluation and Program evaluation:** The Committee discussed the following findings from the Semiannual Inspection held on 11/4/2020 and noted that all findings were minor.

- 1) In [REDACTED] 6255(a) the Committee found an exposed needle on a benchtop.
- 2) In [REDACTED] 6255(a) the Committee found an outdated eyewash tag. Tags must be updated on a monthly basis. This issue was corrected on-site during the facility inspection.
- 3) In [REDACTED] 6255(a) the Committee observed an overfilled medical waste bin and noted that red biohazard bags should be removed when it is 3/4th full.
- 4) In [REDACTED] 6255(a) the Committee observed a hydraulic fluid leak which represents a slip and fall hazard. The elevator vendor inspected and found no new or existing leaks. The fluid is leached fluid from a previous leak. The vendor will inspect the area monthly for leaks and leaching. Facility Management has placed mats on the floor to reduce any risk of slipping.
- 5) In [REDACTED] 6255(a) the Committee found one expired drug that was marked as expired. The expired drug was not being used. EH&S was in the process of working on disposal and the expired drug was shipped out that day.

The Committee also conducted the program evaluation and noted that nothing has changed in the program since the last evaluation.
