Dear Dr. Nattinger,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your July 3, 2020 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the Medical College of Wisconsin. According to the information provided, OLAW understands that on June 17, 2020, a Principal Investigator (PI) received a shipment of four hamsters for a study in which the animals were to be euthanized on the day of arrival without the need for animal facility housing. Two hamsters were euthanized as scheduled and two remaining hamsters were housed overnight in the PI laboratory in separate cages with food and water. The delay in euthanasia of the two remaining hamsters was due to unexpected issues post-euthanasia with schistosome harvesting procedures. The study was supported with PHS funding.

As a corrective measure, the PI promptly reported the situation to the IACUC with a full explanation regarding incorrectly advising laboratory members to house the hamsters in the lab overnight and a misunderstanding regarding animal facility housing options. The two remaining hamsters were moved to the animal facility after consultation with a Staff Veterinarian and animal facility supervisor. The PI reiterated to laboratory staff that animals cannot be housed in the laboratory without IACUC approval and animal facility staff should be consulted if unanticipated concerns arise.

OLAW appreciates the prompt consideration of this matter by the Medical College of Wisconsin which is consistent with the philosophy of institutional self-regulation. Based on the information provided, OLAW is satisfied that appropriate steps have been taken to investigate this incident and to attempt to prevent recurrence. We wish to report a noncompliant situation involving the overnight housing of two (2) hamsters in a laboratory without IACUC approval. This letter will describe the incident and our IACUC's response. We are also notifying AAALAC, International.

Incident

On Wednesday, June 17, 2020, a Principal Investigator (PI) received a shipment of four Syrian hamsters from a collaborator for the purpose of harvesting schistosomes worms. Although the intent was to euthanize all animals on the day of arrival without needing animal facility (BRC) housing, only two hamsters were euthanized and worms collected per the approval protocol; the remaining two hamsters were instead housed overnight in the laboratory in separate cages with food and water. The delay in euthanasia was the result of the study staff using a new protocol for harvest from a hamster model; they encountered unexpected problems with the post-euthanasia harvesting protocol that they had not previously encountered with their usual specialized protocol for mice. The PI accepted full responsibility for housing the remaining animals overnight and promptly reported the situation to the IACUC, explaining that he had not understood that housing in the BRC was an option and had instead communicated to his staff that these animals were not to be housed in the BRC. The two hamsters were subsequently returned to the animal facility after consultation with a Staff Veterinarian and BRC Supervisor.

The PI reiterated to his staff that animals cannot be housed in the laboratory without IACUC approval and that BRC staff should always be consulted if unanticipated problems arise.

IACUC Action

The IACUC discussed the self-report at a meeting on July 1, 2020. Because of the PI's prompt self-report and corrective measures and because the animals showed no adverse effects, the IACUC decided not to take any further disciplinary action.

Records indicate that funding for this study includes a grant from the National Institutes of Health (NIH) entitled *Identification of targets of the antiparasitic drug praziquantel*, 1R01AI14587-01A1.
