- A new farm manager was hired. Dr. Dao is happy with the selection.
- The large animal medical records issue was tabled until next meeting. One of the many challenges has been securing internet access at the farm. The committee reminds us that maintaining animal records is a USDA requirement.
- The age at which goat kids should be allowed on pasture for safety reasons (predation) was discussed. The Farm staff decided that only adults will be allowed on pasture unattended. If goat kids are allowed on pasture, those animals will be accompanied by shepherds.
- There have been substantial improvements in the sheep unit. There is a retaining wall and new roofing for example. The farm staff is looking for someone to run the unit.
- Farm staff will take 1 AS class per semester for training purposes.
- Dr. Dao reported goat injuries due to inappropriate fencing at the goat unit. He will present medical records detailing those injuries. While the committee thought there were improvements to some areas of fencing (plywood patches are intact and adequately covering holes in underlying fencing), it is still in disrepair.

- New IO for Pierce College is Larry G. Buckley. The USDA has been notified of the new Institutional Official.
- The recent USDA inspection was discussed. The conversation included the
 new approach by the USDA to have more talking points vs. citations. We
 reviewed a letter from the farm manager regarding a coyote incident at the
 goat unit where a goat was killed back in June. The IACUC was satisfied that
 several corrections were made to the fencing to prevent any reoccurrence in
 the future. However, the fencing is antiquated and needs replacing (see
 below).
- The farm is currently short staffed as one member is on leave. There was a suggestion to have student assistance on the farm with Marcie supervising in the morning (eg AS 180 and AS 441 students). There was a suggestion to get volunteers to help with facility clean up. It could be called a "farm beautification day". Dr. Yates met with Dr. Andricos who expressed concerns for the farm. As a result I was asked to visit the farm to monitor progress on the issues that she identified on her latest visit. This was done and inspections were documented. (see attached).
- There is still no internet for the farm, therefore electronic medical records are not possible at this time. The large animal medical records are in hard copy form and maintained at the farm. Dr. Dao believes that this system of record keeping is adequate.
- Dr. Dao produced information concerning injuries sustained by several goats
 due to inadequate and dangerous fencing. Some potential funding sources for
 new fencing was discussed. The IACUC will draft a letter to Larry Krause
 stating that fencing is dangerous to animals and personnel and that this issue
 needs to be resolved.

- The ongoing shortage of rabbits for the program was discussed. We have been utilizing students owned rabbits for the past several semesters until a new source is identified.
- Dr. Dao no longer wishes to be the program veterinarian for the program pot-bellied pig. Dr. Yates will now serve in that role.

IACUC Meeting Minutes Convened on May 30, 2019

I. Perform Outdoor and Indoor Facilities Inspections

Outdoor inspection commenced at 5:15 PM. Indoor inspection commenced at 6:15 PM Inspection reports attached.

III. Approve Minutes from Fall 2018 Meeting

Approve minutes: It was brought up that the APHIS inspector, Dr. Andricos, wanted to make sure that the IACUC was satisfied with the measures that were taken to prevent another coyote attack. The chair reminded the committee that a coyote got inside of a goat pen had killed a goat in June 2018. Not all members recall the letter written by the farm manager describing the incident, but they all stated that they were satisfied with the fencing repairs observed during the Fall 2018 inspection. The chair asked Marcie to send a copy of her summary of the incident to all members. She agreed.

Minutes approved unanimously with minor corrections.

Our newest IACUC, Jen Sargent RVT, was introduced and gave us a brief summary of her experience and expertise. One member commented that we might need a "lab animal specialist" for the committee. We will ask Dr. Andricos for clarification on the makeup of our committee and what titles are appropriate. Unfortunately our other new member was unable to attend and hopes to be present for the meeting in the fall.

A summary of the roles and responsibilities of IACUC members and the committee was distributed and discussed. All committee members were given a copy.

VI. Review and Approve Existing Small Animal PVCs

VII. Review and Approve Large Animal PVCs

Course protocol synopses and PVC's were reviewed. There were minor changes made to several protocol synopses as follows:

AS 411

Change student count from 48 students per semester, divided into 3 labs of 16 **TO 39** students per year divided into 3 labs of **13**.

Change venipuncture attempts from 4 per lab to **2** per lab.

The course protocols and PVC's will be completely reviewed by three IACUC members this summer (Yates, Adilini, Killips). The edits and revisions will be sent electronically to all IACUC members for thorough review at our next meeting.

We were uncertain about the pain categories for two of the courses, AS 423 and AS 424. They are currently listed as category "D". We will ask Dr. Andricos for clarification on the categorization.

VIII. New Business

Dr. Andricos was here last week. She asked the chair if the IACUC was aware of the coyote incident from June 2018. I told her that I didn't recall and would refer to my notes. What I did remember is that Marcie wrote a very thorough description of the letter and that the IACUC specifically examined the fencing at the goat unit during the Nov 2018 meeting and was satisfied with the repairs.

The IACUC approved of the letter drafted to inform the administration that the fencing at the goat unit is inadequate. They recommended that it be sent to Paul Neiman. A final copy will be emailed to the committee for approval prior to the letter being sent.

The committee was informed that Dr. Dao would act as farm veterinarian. He has arranged for Conejo Valley Veterinary Hospital as back up. The committee reminded the farm staff that this information needs to be posted and that the Sheriff's department needs to know exactly who to call for veterinary care after hours.

Dr.Dao states that farm animal medical records are available at the goat unit and can be accessed from 7 AM- 3 PM daily. There still is no Internet access at the goat unit so electronic records are not possible at this time. We discussed the lack of communication between the farm and the IACUC committee. There has been no communication about animal health with the committee for two months. Members agreed that this was too long. Dr. Dao was under the impression that he didn't need to inform the IACUC chair (Yates) about any medical issues now that she no longer

consults with him about cases. The committee came to an agreement the committee needs to be informed about major medical issues within 24 hours. One member stated that this is especially important for injuries that seem to be repetitive. Dr. Dao stated that it is too much work to give us a weekly summary. The committee reluctantly agreed to a monthly summary with the option to revise this recommendation if it seems too infrequent or if Dr. Andricos recommends otherwise.

The farm keeps their own venipuncture logs. The committee asked to be shown the location and emphasized the importance of the logs to prevent the overuse of animals in laboratories.

The kennel play yard was discussed. Specifically, dogs that run in the yard injure their footpads because the surface is too aggressive. Over the past several years, the RVT staff proposed many solutions, but all of these recommendations were rejected by the administration. The IACUC believes that this needs to be resolved and is going to ask the administration to solve the problem ASAP. This issue will be added to the letter about goat fencing inadequacy. A related issue is the absence of any shade in the yard. When potted trees were donated to the program the administration would not allow them to be placed in the play yard because they are trees that are not on the official permitted trees for the campus. This issue will be revisited at a later date. We decided to prioritize the yard surface.

Veterinary care for our pot-bellied pig will be provided by Dr. Scott Amsel. Oliver is overdue for his routine exam and it is due to be scheduled soon. Dr. Yates is still the program veterinarian for Oliver.

The farm manager Marcie was asked about recent incidents with the horses. On one evening early in the semester the horses were not fed and apparently there were no records that show whether horses have been fed or not. She stated that this has been remedied. There are now logs that reflect daily horse care located at the equine facility in the food trailer. Another issue is the frequency and quality of horse shoeing being performed on the herd. Paddy Warner has expressed frustration that shoeing was done too infrequently instead of at the standard interval of 8 weeks. Marcie states that she met with Paddy and the Dean and they decided that it would be 8 weeks. At the last horse shoeing, several horses were lame and could not be ridden in equine classes. Marcie commented that in the past Paddy Warner was present for the procedures. Paddy has been on medical leave this semester so has not been available to oversee the shoeing. Marcie suggests that without Paddy being present, perhaps the quality of the work performed has declined. We suggested that one of the experienced farm staff (Marcie or Oscar) be present for at least a part of the procedure to make sure it meets our expectations. Marcie will try but it may be impractical given their farm duties. Lastly, Marcie informed the committee about a horse death that occurred this semester. The horse received appropriate care by our contract equine veterinarians and unfortunately was humanely euthanized due to severe colic.

Dr. Andricos mentioned in a recent inspection that she and Liz had agreed that if sheep are not utilized in RVT classes that she would not need to inspect them. Now that Dr. Dao has taken over the large animal nursing class, he would like to use the sheep in teaching. We reminded him that all the protocols must be in place and updated to reflect their use in laboratories. He agreed.
