Dear Dr. Director,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your January 27, 2020 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the Oregon Health and Science University (OHSU) following up on an initial January 9, 2020 notification by telephone.

According to the information provided, this Office understands that the OHSU Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to: the deaths of 4 prairie voles and euthanasia of one animal because of failure to provide an adequate supply of drinking water. On December 20, 2019, an employee left their work shift early due to medical need. The final report states this employee had begun changing cages in the prairie vole room but had not finished the task. A second employee resumed the task but failed to see 5 cages located on a rack separated from the rest of the colony. Consequently, water bottles were not replaced on these 5 cages. The daily observation of the animals in these cages did not occur. The next day the error was discovered, and four prairie voles were found dead and one found moribund. The Department of Comparative Medicine veterinary staff examined the animals and euthanized the moribund vole. New, full water bottles and soft food were provided immediately to all five cages. The remaining voles recovered without incident.

The incident was reported to the OHSU Central and Waterfront Campus IACUC at their January 15, 2020 meeting. A plan was presented and approved by the IACIC and included the following:

•A health check is required, including observations of the animals and of food and water supplies, for all cages in any room if a worker needs to leave the facility before they can complete all room husbandry tasks.

It is noted these animals were involved in PHS supported animal activities. Based on the information provided, the Office of Laboratory Animal Welfare (OLAW) is satisfied that appropriate actions have been taken to investigate, correct, and prevent recurrence of the noncompliance. We appreciate being informed of these matters and find no cause for further action by this Office.

Dear Dr. Morse:

The Oregon Health & Science University (OHSU), in accordance with Assurance D16-00195 (A3304-01) and PHS Policy IV.F.3., provides this report of a failure to provide an adequate supply of drinking water, resulting in the death of four prairie voles and immediate euthanasia of one animal. This was first reported to you on January 9, 2020 via a telephone call from Vickie L. Jarrell, Ph.D., Director, Animal Care and Use Program, OHSU Research Integrity Office.

In summary, this incident was the result of miscommunication between animal care personnel. One employee left their work shift early on 12/20/2019 due to a medical need. This employee had begun changing cages in the prairie vole room but had not finished the task. A second employee resumed the task but failed to see five cages located on a rack separated from the rest of the colony. Consequently, water bottles were not replaced on these five cages. The daily observation of the animals in these cages did not occur.

The error was discovered on 12/21/2019. Four prairie voles were found dead in three separate cages. A fifth vole was moribund. Water bottles on the two remaining cages had a limited supply of water available. The Department of Comparative Medicine (DCM) veterinarians were notified immediately. DCM veterinary staff examined the animals, and euthanized the moribund vole. New, full water bottles and soft food support were provided immediately to all five cages. The remaining voles recovered without incident.

A review of the billing records showed that all direct costs associated with the procurement and care of the prairie voles were paid from OGA Award/Project #ABNEU0403/GBNEU0403C. The expenditures associated with this incident were of a minimal nature not requiring refunding of the grant.

This incident was reported to the OHSU Central and Waterfront Campus (CWC) IACUC at their 01/15/2020 meeting. A mitigation plan was presented to the committee. The mitigation plan was approved by the CWC IACUC and included the following:
