The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your January 13, 2020 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Nevada, Las Vegas as a follow-up to the preliminary report submitted November 22, 2019. According to the information provided, OLAW understands that on November 21, 2019, the IACUC was informed that an animal care staff member discovered a mouse with a suture on its side which is unusual for the colony. IACUC records and associated approved protocol had no approved surgical procedures listed. The principal investigator (PI) was contacted and all work except husbandry and care was immediately halted. The study is PHS funded and the PI was directed to report the non-compliance to the project sponsor immediately.

As a corrective measure, the following actions were implemented by the IACUC:

- The undergraduate student who performed the surgery was prohibited from accessing live animals until she retakes the CITI training and completes the initial 3 hour in-person training required of all the PI's staff.
- All approved future surgeries will include observation of the initial surgery by an experienced surgeon or someone approved by the IACUC Chair and University Veterinarian. If the observer believes additional training is necessary, the IACUC chair will be informed and prompted to review the recommendation and implement additional training as needed.
- The PI was directed to attend six IACUC monthly meetings in 2020 to become familiar with action and responsibilities of the IACUC.
- The PI was directed to post a one-page summary of allowable (approved) procedures in the mouse room and distribute this information to the employees that are approved to work with animals.
- A copy of the Guide for Care and Use of Laboratory Animals was provided to the PI and the was PI directed to summarize pertinent sections in a three hour in-person training session to their staff in the Spring and Fall 2020 semesters. Additionally, all workers listed on the approved protocol from the laboratory are mandated to attend one or both sessions. This training is intended to ensure staff are aware of animal welfare and responsible animal care.

OLAW appreciates the prompt consideration of this matter by the University of Nevada, Las Vegas which is consistent with the philosophy of institutional self-regulation. Based on the information provided, OLAW understands that one mouse was involved in this non-compliance event with no adverse animal health outcomes (e.g. illness, death) reported and therefore OLAW is satisfied that appropriate actions have been taken to investigate this incident and prevent recurrence. In accordance with Assurance A3774-01 and PHS Policy IV.F.3, I am writing to you to submit a final report related to mouse survival surgeries (total of 3 mice) without IACUC approval.

As a reminder, on Thursday, November 21, 2019, the IACUC was informed that an animal care staff member discovered a mouse with a suture on its side and noted this as unusual for this colony. IACUC records were reviewed and the associated IACUC approved protocol has no approved surgical procedures. The UNLV IACUC immediately contacted the Principal Investigator (PI) and noted all work except for husbandry and care be immediately halted until an investigation was completed.

This project is funded through the National Institutes of Health. The PI was directed to report this to the sponsor immediately.

After meeting with the involved parties to better understand the timeline and processes leading up to the surgeries, the IACUC initiated the following corrective actions:

- A copy of the Guide for the Care and Use of Laboratory Animals was provided to the PI. The PI was directed to summarize pertinent sections in three-hour in-person training sessions to their staff in the Spring and Fall semesters of 2020. Additionally, all workers listed on the approved protocol from the laboratory were mandated to attend one or both sessions. This training is intended to ensure staff are aware of animal welfare and responsible animal care.
- 2) The PI was directed to post a one page summary of allowable procedures in the mouse room and distribute this information to the employees that are approved to work with animals.
- 3) The PI was directed to attend six IACUC monthly meetings in 2020 to become better familiarized with the actions and responsibilities of the IACUC.
- 4) All approved future surgeries will include observation of the initial surgery by an experienced surgeon or someone approved by the IACUC Chair and University Veterinarian. If the observer believes additional training is necessary, he or she can inform the IACUC Chair, who will review the recommendation and implement additional training as necessary.

Maryland Parkway · Las Vegas, NV 89154-1087 Tel: 702-895-5948 unlv.edu/research/integrity 5) The undergraduate student who performed the surgical activities was prohibited from accessing live animals until she re-takes the online CITI training courses, provides evidence of completed training records of these courses, and completes the initial 3 hour in-person training required of all the PI's staff as noted above.

This non-compliance was determined to be a result of poor communication between a PI and his student as well as inadequate PI oversight. This was deemed to be an individual and isolated action (i.e., not systemic) and therefore the IACUC determined no additional actions beyond those outlined above were necessary.


