## ATTACHMENT A

On March 26, 2020, OLAW granted UCLA a temporary waiver to PHS Policy IV.B.2 due to the COVID-19 pandemic and corresponding ramp-down of on-campus activities and operations. Consequently, some facility inspections were delayed in Fall/Winter 2020/2021 due to the surge in COVID-19 cases in Los Angeles.

Due to accessibility issues introduced during the pandemic, the IACUC made use of certain flexibilities allowed by OLAW, including use of the AAALAC triennial site visit and remote methods of inspections.
