Dear Dr. O'Byrne,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your February 18, 2022 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the Wake Forest University (WFU). This letter had not been preceded by a preliminary report to OLAW.

According to the information provided, this Office understands that the WFU Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to: the conduct of animal activities without prior IACUC review and approval. The final report states a research team selfreported an incident involving animals that underwent a hypercapnia challenge procedure that was not in the approved IACUC protocol. It is understood the procedure is approved in a different protocol by the same Principal Investigator (PI). It is stated the research team is well trained on this procedure and no adverse events or negative impact on animal health were observed.

In response to the incident, a Notification of Correction Letter was provided to the PI emphasizing the importance of strictly adhering to the IACUC-approved protocol. Per the report, all actions have been completed and the IACUC considers this matter resolved.

It is noted that this research is supported by PHS funding. Based on its assessment of this explanation, OLAW understands that the Wake Forest University has implemented appropriate measures to correct and prevent recurrences of these problems and is now compliant with provisions of the PHS Policy.

We appreciate being informed of these matters and find no cause for further action by this Office.

This is an official notification that the Wake Forest University (WFU) Animal Care & Use Program identified and resolved a deviation from standard procedure, which the WFU Institutional Animal Care and Use Committee (IACUC) determined must be reported to your office.

PHS Funding:

In accordance with federal expectations, the WF IACUC has forwarded information regarding this incident to our the WF School of Medicine sponsored research office, which will review relevant direct costs associated with the procurement, care and use of the animal(s) related to this deviation. Relevant costs will be paid from a nonfederal source, as appropriate.

Incident:

A protocol deviation was self-reported by a research team in which animals underwent a hypercapnia challenge procedure that was not in the approved IACUC protocol. This procedure is approved in a different protocol by the same principal investigator. The research team is well trained on this procedure and no adverse events or negative impact on animal health occurred.

Preliminary Report:

No preliminary report was made to OLAW regarding this incident.

Resolution:

The IACUC approved the following actions to resolve this incident:

A Notification of Correction Letter was sent to the PI reiterating the importance of strictly adhering to the approved IACUC protocol. The IACUC acknowledges the self-report by the PI. All actions have been completed/implemented at this time, and the WFU IACUC considers this matter closed. Program oversight staff will continue to monitor animal care and use procedures to ensure compliance with IACUC approved processes.
