The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your January 7, 2022, letter regarding an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of California- San Francisco. According to the information provided, OLAW understands that mice from one cage undergoing  $CO_2$  euthanasia were left unattended by a lab member. There were no adverse events as a result of the noncompliance on this PHS-supported activity, and euthanasia was subsequently confirmed by LARC staff.

The corrective actions consisted of the responsible lab member completing euthanasia retraining and all lab personnel reviewing and confirming understanding of UCSF's IACUC Euthanasia policy. Additional lab members have been assigned as backup for any lab member whose primary responsibility is animal care.

Based on the information provided, OLAW is satisfied that appropriate actions have been taken to investigate, correct and prevent recurrence of the noncompliance. We appreciate being informed of these matters and find no cause for further action by this Office.

## Dear Dr. Morse,

This letter serves as final follow-up to our preliminary non-compliance report to OLAW on January 27, 2021.

On November 19, 2020, a lab member left mice unattended during CO<sub>2</sub> delivery to the cage for an NIH-funded study. The LARC staff discovered the cage, confirmed euthanasia with no adverse effects, and immediately notified the IACUC office and LARC veterinarian.

## Follow-up and Corrective Action:

- 1. The lab member completed euthanasia retraining with IACUP staff.
- 2. All lab members reviewed and confirmed understanding of UCSF's IACUC Euthanasia policy.
- 3. Additional lab staff are now assigned as backup when competing priorities arise for any lab member whose primary responsibility is animal care.

## Completion:

As of the date of this letter, corrective actions #1-3 above are completed and implemented. The laboratory is currently in compliance with UCSF and PHS standards. I believe the steps taken will help ensure future compliance and prevent reoccurrence. If you have any additional questions, please do not hesitate to contact me or the IACUP Director.
