Dear Dr. Thompson-Iritani,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your February 3, 2022 letter reporting a noncompliance with the PHS Policy on the Humane Care and Use of Laboratory Animals at the University of Washington. Your letter supplements the information in the prompt preliminary telephone report on December 16, 2021. According to the information provided it is understood that on Sunday, December 5, 2021, cages in two mouse housing rooms in the ABSL3 facility did not receive the daily health check. The animals were checked the next morning and no unexpected health conditions were noted. The animals in question were not supported by PHS funds.

Corrective and preventive actions:

- Animal care staff will continue to review upcoming daily health check assignments during the team's weekly meeting.
- For days in which animals are scheduled to be in the facility, yet DCM personnel are not otherwise scheduled to work onsite (e.g., weekend and holidays):
 - continue to note daily health check assignments on the team's calendaring system which is visible to all team members.
 - o initiate a new process whereby delivery of an email to all team members is scheduled to occur on or immediately before the weekend/holiday day(s).

Current team members have been trained/retrained on these procedures. These procedures will be included in the training of future team members.

OLAW believes that the corrective and preventive measures put in place by the University of Washington are consistent with the provisions of the PHS Policy on Humane Care and Use of Laboratory Animals for institutional self-monitoring and self-reporting. We appreciate being informed of this matter and find no cause for further action by this office.

Dear Dr. Morse:

This is a final report on an adverse event reported to OLAW by Dr. Stocking in a telephone call on 12/16/21.

ABSL3 Department of Comparative Medicine (DCM) personnel are to do animal health checks every day animals are present in the facility. On Sunday 12/5, cages in 2 different mouse housing rooms in the ABSL3 facility did not receive the daily health check by DCM personnel. As animals are not continuously housed in the ABSL3 facility, DCM has multiple routine practices in place to help ensure personnel are aware of the weekend and holiday days they must travel to the facility to perform health checks: personnel are scheduled in advance and a notation is made on the DCM management shared calendar; a standing agenda topic during their weekly Thursday meeting is to review animal health check assignments for the upcoming week. In this instance, both practices occurred. This individual did notify the ABSL3 Facility Director of this error the next morning and immediately entered the facility to check on the animals. No unexpected health conditions were noted.

Corrective actions:

- Continue to review upcoming daily health check assignments during the team's weekly meeting.
- For days in which animals are scheduled to be in the facility, yet DCM personnel are not otherwise scheduled to work onsite (e.g., weekend and holidays):
 - o continue to note daily health check assignments on the team's calendaring system which is visible to all team members.
 - o initiate a new process whereby delivery of an email to all team members is scheduled to occur on or immediately before the weekend/holiday day(s).

Current team members have been trained/retrained on these procedures. These procedures will be included in the training of future team members.

The IACUC reviewed the incident at its January meeting and found no further action necessary (considers the case closed.) The animals in question were not supported by PHS funds.
