She worked for 5 years in GLP CROs prior to joining UCSF.

Authority: has delegated program authority and responsibility for the Institution's animal care and use program including access to all animals.

Time contributed to Program: Full Time Employee with 100% time dedicated to the animal care and use program.

Mission Bay Campus now includes a recently completed and opened vivarium, which includes 12,046 ft² for procedure space and 7,433 ft² for animal housing of mainly rodents (2500 cages average daily census) and a small number of frogs (not yet housed within the space).
