This represents the semiannual report of the Institutional Animal Care and Use Committee (IACUC), as required by the PHS Policy on Humane Care and Use of Laboratory and as a condition of this institution's Animal Welfare Assurance on file with the Office of Laboratory Animal Welfare (OLAW), and USDA Animal Welfare Regulations, 9 CFR Chapter I, subchapter A, as applicable.

#### Evaluation of the Animal Care and Use Program

1. The IACUC conducted its semiannual evaluation of the institution's animal care and use program on April 22, 2022, using the 8<sup>th</sup> Edition of the *Guide for the Care and Use of Laboratory Animals (Guide)*, and, as applicable, 9 CFR Chapter I, 2.31

The Committee used the NRC Guide for the Care and Use of Laboratory Animals and other pertinent resources, e.g., the PHS Policy, the Code of Federal Regulations (Animal Welfare) as a basis for the review. To facilitate the evaluation, the Committee used a checklist based on the Sample OLAW Program and Facility Review Checklist from the OLAW website. The evaluation included, but was not necessarily limited to, a review of the following: a) IACUC Membership and Functions; b) IACUC Records and Reporting Requirements; c) Husbandry and Veterinary Care (all aspects); d) Personnel Qualifications (Experience and Training); e) Occupational Health and Safety; and f) disaster planning. In addition, the evaluation included a review of the Institution's PHS Assurance. No member was involuntarily excluded from participating in any portion of the review.

Accreditation.

The Institution's Program for Laboratory Animal Care and Use is accredited by the Association for the Assessment and Accreditation of Laboratory Animal Care International (AAALAC-Int'l). The AAALAC accreditation site visit occurred March 21, 2022- March 22, 2022. Continued full reaccreditation was recommended by the site visitors. A final determination is expected in May 2022.

3. IACUC Approved Departures from the NRC "Guide", PHS Policy and the AWA.

The reason for these exemptions to Regulations are listed below:

#### USDA

"IACUC Functions: Review ... programs ... and inspect ... using the [USDA regs] as a basis for evaluation. [IACUC] reports must contain a description of ... facility's adherence to the [USDA regs] and must identify specifically any departures [from them] and must state the reasons for each departure."

PHS Policy p. 7

"Functions of the IACUC review ... programs ... inspect using the Guide as a basis for evaluation." "[IACUC] reports must contain a description of the nature and extent of the Institution's adherence to the Guide and this Policy and must identify specifically any departures from the provisions of the Guide and this Policy and must state the reasons for each depart."

9 CFR AWA Part 3 (Subpart B) §3.28(b)(3)(i)

"The interior height of any primary enclosure used to confine hamsters shall be at least 6 inches."

Roborovskii dwarf hamsters (P. roborovskii) have been housed in 5-inch-high cages because it is documented that 6-inch-high cages are detrimental to the growth of a similar sized hamster species (P. sungorus) [Gilman WC, et.al "Effect of the New USDA Cage Height Standard on Body Weights of Weanling and Djungarian Dwarf Hamsters (Phodopus sungorus). Contemporary Topics in Lab Animal Science, 32(1): 17-19, 1993.]

#### 9 CFR AWA Part 3 (Subpart B) §3.31(a) (1)

"[Hamster] enclosures shall be sanitized at least once every 2 weeks..."

- Nursing Syrian hamster cages may go for more than 14 days between cage changes due to pre-parturition cage change and post-parturition cage change interval.
- b. Cage accessories (wire bar top, food hopper, solid cage top, filter top) are changed outfor all rodent species quarterly congruent with the findings in the article entitled "Investigation of Appropriate Sanitization Frequency for Rodent Caging Accessories: Evidence Supporting Less-frequent Cleaning" as found in JAALAS, 45(6), 40-43, 2006;as well as in-house ATP testing performed between March 2019 and April 2019.

#### 9 CFR AWA Part 3 (Subpart B) §3.33

"Animals housed in the same primary enclosure shall be maintained in compatible groups, ..."

a. It is essential to be able to manipulate social housing conditions to study the effects of social experience on brain and behavior, so some Syrian Hamsters are singly housed. That would include experimental animals that were ordered and only ever singly housed, the Resident Aggressor (RA) colony, breeders (that may or may not have a litter with them), and any group housed animals that were eventually singly

- housed to become experimental animals, RAs, or breeders. Syrian Hamsters are solitary and territorial animals in the wild.
- Social hierarchy paradigm: One hamster will be placed into each of the 4 b. compartments for an acclimatization period of up to 3 days with food and water readily available. After habituation, the dividers will be removed to allow the hamsters to interact freely and establish a hierarchy. Initial hierarchy establishment will be monitored by a live observer and hamsters will be allowed to freely interact for up to 7 days but will not spend a more than a total of 8 days in the apparatus. Hamster rank within the hierarchy will be determined using the percentage of agonistic encounters won, average distance covered over the interaction days and other behavioral measures. To assess long-term hierarchy maintenance, animals may be reintroduced to the apparatus for the abovementioned period.

NRC "Guide to the Care and Use of Laboratory Animals", 8th Edition, pg.70 "Cleaning and Disinfection of the Microenvironment. In general, enclosures and accessories, such as tops, should be sanitized at least once every 2 weeks.

Cage accessories (wire bar top, food hopper, solid cage top, filter top) are changed out for all rodent species quarterly congruent with the findings in the article entitled "Investigation of Appropriate Sanitization Frequency for Rodent Caging Accessories: Evidence Supporting Less-frequent Cleaning" as found in JAALAS, 45(6), 40-43, 2006; as well as in-house ATP testing performed between March 2019 and April 2019.

NRC "Guide to the Care and Use of Laboratory Animals", 8th Edition, pg.44 Recommended Dry-bulb macroenvironmental temperatures for common lab animals." Drybulb room temperature settings for rodents are typically set below the animals' LCT to avoid heat stress and should reflect different species-specific LCT values.

Housing mice in thermo-neutral (~85°F) or cold (40°C) housing with IACUC approval.

NRC "Guide to the Care and Use of Laboratory Animals", 8th Edition, pg.111 "Physical separation of animals by species is recommended to prevent interspecies disease transmission and to eliminate the potential for anxiety and physiologic and behavioral changes due to interspecies conflict.

Housing mice and Robo hamsters in ABSL3 (same room, separated in different IVCs.)

NRC "Guide to the Care and Use of Laboratory Animals", 8th Edition, pg.66 "Most natural-ingredient, dry laboratory animal diets stored properly can be used up to 6 months after manufacture. Non-stabilized vitamin C in manufactured feeds generally has a shelf life of only 3 months, but commonly used stabilized forms can extend the shelf life of feed. Refrigeration preserves nutritional quality and lengthens shelf life, but food storage time should be reduced to the lowest practical period and the manufacturers' recommendations considered. Purified and chemically defined diets are often less stable than natural-ingredient diets and their shelf life is usually less than 6 months (Fullerton et al. 1982); they should be stored at 4°C (39°F) or lower."

#### 4. Program Deficiencies.

Members of the Committee, or ad hoc Inspectors, visited all the institution's facilities where live animals are housed or used, i.e., holding areas, animal care support areas, storage areas, and procedure areas. The Committee, or ad hoc members, used the NRC Guide and other pertinent resources, e.g., the PHS Policy, the Code of Federal Regulations (Animal Welfare) as a basis for the inspection. To facilitate the evaluation, the Committee, or ad hoc members, used a checklist based on the Sample OLAW Program and Facility Review Checklist from the OLAW website. No member was involuntarily excluded from participating in any portion of the inspection.

#### 2. Facility Deficiencies.

Attached is a list of deficiencies. As required, the Committee categorized them as significant or minor (a significant deficiency is one that is or may be a threat to the health and safety of the animals or personnel) and developed a reasonable and specific plan and schedule for correcting each deficiency. All other aspects of the program are consistent with the PHS Policy, the Guide, and applicable Animal Welfare Regulations.

- \* In addition to PHS requirements for IACUC review/application for funding, USDA regulations require:
  - 2.31(d)(1)(ii) "The principal investigator (PI) consider alternatives to procedures that cause more than momentary or slight pain or distress to the animals, and has provided a written narrative description of the methods and sources...used to determine that alternatives were not available."
  - 2.31(d)(1)(iii) "The PI has provided written assurance that the activities do not unnecessarily duplicate previous experiments."
  - 2.31(d)(1)(iv) "Procedures that may cause more than momentary or slight pain or distress to the animals will:
  - involve in their planning, consultation with the attending veterinarian or his or her designee; [PHS Policy does not specify veterinary consultation]
  - not include paralytics without the use of anesthesia;"
  - 2.31(d)(1)(x) "No animal will be used in more than one major operative procedure from which it is allowed to recover, unless justified for scientific reasons by the principal investigator, in writing..."

- xi 2.33(a)(1) "In the case of a part-time attending veterinarian or consultant arrangements, the formal arrangements shall include a written program of veterinary care and regularly scheduled visits to the research facility." [USDA requirement additional]
- xii 2.32(c) "Humane methods of animal maintenance and experimentation, including the basic needs of each species, proper handling and care for the various species of animals used by the facility, proper pre-procedural and post-procedural care of animals, and aseptic surgical methods and procedures."
- xiii 2.32(c) additional specifications include:
- "proper use of anesthetics, analgesics, and tranquilizers for any species of animals used by the facility"
- "methods whereby deficiencies in animal care and treatment are reported, including deficiencies in animal care and treatment reported by any employee of the facility..."
