Dear Dr. Nobles,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your June 9, 2022 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the Emory University following up on an initial April 22, 2022 notification by telephone.

According to the information provided, this Office understands that the Emory University Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to the failure to adhere to institutional policies, the conduct of an unapproved experimental study, and the use of an unapproved substance. The final report states on March 7, 2022, a lab performed an experimental study that was not approved in the protocol and used an unapproved virus vector in the study. On March 9th, it was determined the lab had overcrowded mouse cages, which resulted in the deaths of 3 mice, and had a weaning policy violation. The following corrective actions were implemented in response to the noncompliance:

- The vet staff assumed monitoring responsibilities of experimental animals.
- The lab was told to stop research with the unapproved agent, to meet with the Vice President of Research Compliance and Regulatory Affairs to discuss the issues, and to have their breeding colonies transferred to Managed Breeding Services.
- The IACUC office performed a PAM with the lab to discuss correctly following their approved protocol.
- The IACUC Full Committee voted to suspend the protocol and recommended that a new protocol be submitted.

It is noted that this research is supported by NIH funding. Based on its assessment of this explanation, OLAW understands that the Emory University has implemented appropriate measures to correct and prevent recurrences of these problems and is now compliant with provisions of the PHS Policy.

We appreciate being informed of these matters and find no cause for further action by this Office.

Dear Dr. Tubbs,

The Emory University Institutional Animal Care and Use Committee (IACUC), through the Institutional Official, is reporting the results of an event as required by section IV, F, 3a of the Public Health Service Policy on Humane Care and Use of Laboratory Animals (PHS Policy). A preliminary report was provided via phone call to your office on 4/22/22. This is the final report regarding a protocol violation where an unapproved experiment study was conducted, an unapproved substance was used, a university policy was violated and animal welfare where three mice deaths occurred. The associated NIH-funded grants are 1 R01 CA255257-01A1, P50 CA217691, and R01CA200905.

Situation and Assessment

On March 7th, 2022, it was determined that the lab was performing an experimental study that was not approved in the protocol and that the lab used an unapproved virus vector in the experimental study. On March 9th, 2022, it was discovered that the lab had overcrowded mice cages which resulted in three mice deaths and had a weaning policy violation.

The corrective actions to prevent a recurrence were:

- On March 8th, vet staff assumed monitoring responsibilities of experimental animals.
- On March 9th, the lab was told to stop research with the unapproved agent, to meet with the Vice President of Research Compliance and Regulatory Affairs to discuss the issues at hand, and to have their breeding colonies transferred to Managed Breeding Services.
- On March 18th, the IACUC office performed a PAM with the lab to discuss correctly following their approved protocol.
- On April 20th, the IACUC Full Committee voted to suspend the protocol and recommended that a new protocol be submitted.

The IACUC believes its investigation of this incident was thorough and the corrective actions appropriate to prevent a similar occurrence. If you have questions regarding this incident, please contact me or (b) (6)
