Dear Dr. Bonnell,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your December 14, 2021 letter reporting an adverse event at the University of Pennsylvania. This letter had not been preceded by a preliminary report to OLAW.

According to the information provided, this Office understands that the University of Pennsylvania Animal Care and Use Committee (ACUC) determined that an adverse occurred with respect to: the deaths/euthanasia of nine gerbils. The final report states that gerbils were inoculated with parasitic larvae as described in an IACUC-approved protocol. It is stated the inoculum was prepared using standard methods, but an acute nature of illness developed suggesting the inoculum was contaminated. The Principal Investigator (PI) contacted the veterinary staff and veterinary diagnostic laboratory for assistance once the event occurred. In response, the PI developed a mitigation plan and included an additional purification step to the larval isolation procedure. Per the report, the IACUC Compliance Subcommittee accepted the PI's plan.

It is noted that this project is supported by PHS funding. Based on its assessment of this explanation, OLAW understands that the University of Pennsylvania has implemented appropriate measures to prevent future recurrence of this type of incident. Please notify OLAW if the problem persists or is not solved.

We appreciate being informed of these matters and find no cause for further action by this Office.

Dear Dr. Morse,

The University of Pennsylvania is reporting an adverse event which resulted in the accidental death/euthanasia of nine gerbils. The gerbils were inoculated subcutaneously with parasitic larvae as part of an IACUC-approved parasite treatment study. The inoculum was prepared by standard methods, however the acute nature of illness suggested it must have been contaminated. Once the event occurred, the PI immediately notified the veterinary staff and veterinary diagnostic laboratory for assistance in the case. To avoid this outcome in the future, the PI developed a mitigation plan and has added an additional purification step to the larval isolation procedure. The IACUC Compliance Subcommittee was informed of the incident and has accepted the PI mitigation plan. The project was funded by a subaward of grant 5 R21 AL149037-02 and the sponsor was also notified.
