Dear Dr. Pipher,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your January 26, 2022 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the Brown University. This letter had not been preceded by a preliminary report to OLAW.

According to the information provided, this Office understands that the Brown University Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to: animals with lack of access to water. The final report states that three mice were found dead on November 26, 2021. It was determined a Center for Animal Resources and Education (CARE) technician did not ensure the water bottle was properly seated, which prevented access to water.

The IACUC discussed the matter at its January 14, 2022 convened meeting and determined the matter was reportable to this Office. In response to the incident, the following corrective actions were established:

- The individual responsible for checking the cage daily prior to the incident has received disciplinary action through Brown University HR.
- All CARE technicians received hands-on retraining by a CARE manager in the use of this type of caging and in general husbandry practices.

It is noted that the final report did not include the funding source involving the incident. In the future, please include the source of funding and provide grant numbers for all PHS, NSF or NASA supported work.

Based on its assessment of this explanation, OLAW understands that the Brown University has implemented appropriate measures to correct and prevent recurrences of these problems and is now compliant with provisions of the PHS Policy.

We appreciate being informed of these matters and find no cause for further action by this Office.

The Brown University Institutional Animal Care and Use Committee (IACUC), through the Institutional Official (Jill C. Pipher, Ph.D.), is writing to provide OLAW with a final report of the following noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals ("PHS Policy"):

On November 26, 2021, three mice were found deceased by a Center for Animal Resources and Education (CARE) technician. It was determined that a CARE technician had not ensured that the water bottle was properly seated, thus preventing access.

The IACUC discussed the incident of animal welfare concern at its January 14, 2022 convened meeting and determined that the incident meets the criteria for reporting per the NIH NOT-OD-05-034, "Guidance on Prompt Reporting to OLAW under the PHS Policy on Humane Care and Use of Laboratory Animals."

The following corrective actions have taken, or will take, place:

- The individual responsible for checking the cage daily prior to the incident has received disciplinary action through Brown University HR
- Additionally, all CARE technicians received hands-on retraining by a CARE manager in the
 use of this particular type of caging and in general husbandry practices.
