Dear Mr. Hodgson,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your July 14, 2021 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the Children's Hospital of Philadelphia (CHOP). This letter had not been preceded by a preliminary report to OLAW.

According to the information provided, this Office understands that the CHOP Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to: rabbits escaping their primary enclosure. The final report states in May and April 2021, there were six instances involving rabbits escaping from their cages. In one incident, a rabbit was found with edema and erythema of the upper lip and subsequently received a dose of analgesia and recovered uneventfully. Another incident involved a rabbit found with a spinal injury resulting in paralysis, and the decision was made to euthanize the animal.

The IACUC discussed these events at the meeting held on June 14, 2021. It is stated a thorough assessment of the rabbit caging revealed several factors which facilitated the rabbits' ability to escape from their primary enclosures. In response, the Department of Veterinary Resources husbandry team requested the vendor come on site to assess the caging, ordered, and replaced worn parts, and began sourcing replacement caging from multiple vendors. It is understood the IACUC voted to report the matter to this Office.

The final report also notes that these animals were not supported by PHS funds. Based on its assessment of this explanation, OLAW understands that the Children's Hospital of Philadelphia has implemented appropriate measures to correct and prevent recurrences of these problems. We appreciate being informed of these matters and find no cause for further action by this Office.

The Children's Hospital of Philadelphia (CHOP), in accordance with Assurance D16-00280 (A3442-01) and PHS Policy IV.F.3., submits this report of noncompliance regarding the following incident:

In the months of April and May 2021, the DVR staff reported six incidents of rabbits escaping from their cages within the animal facility. In one such instance, a single animal was found with edema and erythema on the upper lip. The rabbit was examined by a Department of Veterinary Resources (DVR) veterinarian and administered a dose of meloxicam. This animal recovered without further issues or need for additional analgesics. In a subsequent incident, another animal was found with a spinal injury after jumping from the top cage. This resulted in the animal becoming paralyzed which affected mobility. The DVR veterinary team assessed the animal and made the decision to euthanize immediately. No NIH funding was used to support these animals.

These incidents were discussed at our regularly scheduled monthly IACUC meeting on 6/14/2021. No subsequent escapes have occurred. In doing a thorough assessment of existing rabbit caging, several factors were discovered which facilitated the above-mentioned animals being able to escape from their primary enclosures. Considering these findings, the DVR husbandry team immediately requested the vendor come on site to assess the caging, ordered and replaced worn parts, and began sourcing replacement caging from multiple vendors. The IACUC voted to report this incident to the Office of Laboratory Animal Welfare (OLAW), with a copy to AAALAC International.

The CHOP Research Institute and the IACUC is committed to the highest levels of animal care and welfare. While unexpected and unfortunate, we believe these steps taken to address the equipment failures are appropriate to address the issues that were identified.
