Dear Dr. Giannelis,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your August 13, 2021 letter reporting an incident of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals within the animal care and use program at Cornell University. According to the information provided, OLAW understands that the Cornell University Hospital for Animals anesthesia department provided anesthesia for experimental orthopedic surgery on 24 sheep. The anesthesia department did not administer intra-articular local anesthetic as outlined in the protocol. Instead, a local saphenous nerve block was used in combination with a pre-operative fentanyl patch and perioperative meloxicam. No break-through pain was observed. The discrepancy was found during an AAALAC site visit. The sheep involved in this incident were supported by NIH funding.

Corrective and preventive measures included counseling of the laboratory staff about the importance of following the approved IACUC protocol. The laboratory has submitted an amendment to include the local saphenous nerve block as an alternate method of anesthesia.

OLAW appreciates the consideration of this matter by Cornell University which was consistent with the philosophy of institutional self-regulation. Based on the information provided, OLAW is satisfied that appropriate actions have been taken to investigate this incident and prevent recurrence. We appreciate being informed of this matter and find no cause for further action by this office.

Dear Dr. Wolff:

As Institutional Official for Cornell University's animal care and use program, I am reporting an issue of noncompliance that occurred under our General Assurance. This incident involved twenty-four sheep and occurred between May 21, 2021 and June 25, 2021. This issue was reported to the IACUC at the July 22, 2021 meeting, and the IACUC agreed that the corrective actions taken were appropriate.


### **Explanation of the situation:**

During the AAALAC site visit, it was determined that orthopedic surgery had been performed on 24 sheep between 5/21/21 and 6/25/21. The Cornell University Hospital for Animals (CUHA) anesthesia department provided anesthesia to the animals and did not administer pre-operative or post-operative intra-articular local anesthetic as outlined in the protocol. Instead, CUHA Anesthesia staff administered a local saphenous nerve block. In the CUHA Anesthesiologist's and PI's judgement, the saphenous nerve block, in combination with the pre-op fentanyl patch and pre-op and post-op meloxicam provided adequate analgesia. No break-through pain was evident on the daily post-operative monitoring records.

### Action taken by the institution:

CARE veterinary staff contacted the lab staff about the discrepancy in the experimental records and the plan as outlined in the protocol. CARE veterinary staff reminded the lab staff about the importance of following the approved IACUC protocol. The lab has submitted a protocol amendment to include local saphenous nerve block as an alternate method of anesthesia.
