Dear Dr. Muto,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your September 9, 2021 letter reporting an adverse event involving the animal care and use program at Harvard Medical School. According to the information provided, OLAW understands that on July 1, 2021, a shipment of mice from the Harvard Medical School was received at another institution wherein 25 of the 133 mice shipped were dead on arrival. The mice were supposed to be on a night flight, but the airline changed the routing and put the mice on a flight that departed when it was 88°F outside. Based on necropsy and histopathology results, the suspected cause of death in these mice was heat stroke. It was stated that this animal activity was funded by the PHS.

Corrective and preventive actions included the courier instituting new guidelines for animal air travel. Animals will not be held at any airport when the temperature rises above 80°F. Animals will be collected by the courier if the temperature rises above this temperature during a connection and put on the next safe flight.

OLAW appreciates the actions taken by Harvard Medical School regarding this unfortunate matter. Based on the information provided, OLAW is satisfied that appropriate actions have been taken to investigate the incident and to prevent recurrence. We appreciate being informed of this matter and find no cause for further action by this office.

This letter serves as a final report on an adverse event that has not been preliminarily reported to OLAW by the Harvard Medical Area Standing Committee on Animals (HMA IACUC).

On July 1, 2021, the University of California, San Francisco received an import of mice from the Harvard Medical School in which 25 animals of the 133 mice shipped were dead on arrival. The mice were supposed to be on a night flight, but the airline changed the routing and put the mice on a flight that departed when it was 88°F outside. Based on necropsy and histopathology results, the suspected cause of death in these mice was heat stroke.

To prevent this from occurring again, the courier has instituted new guidelines for animal air travel. Animals will not be held at any airport when the temperature rises above 80°F. Animals will be collected by the courier if the temperature rises above this temperature during a connection and put on the next safe flight.

The Committee is satisfied with the corrective actions mentioned above and considers this incident to be resolved. Please let us know if any additional information is required at this time.
