The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your May 17, 2021 letter reporting a noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals within the animal care and use program at the Texas Biomedical Research Institute. Your letter supplements the initial information contained in the report received on March 15, 2021. According to the information provided, OLAW understands that an unanticipated inclement weather event resulted in a number of non-life-threatening, weather-related injuries, including frostbite, to the baboon colony at the Southwest National Primate Research Center. These animals are supported by the PHS.

Immediate corrective actions included providing additional supplemental heat and overnight observations. Staff provided continual care and observations to allow animals identified with weather related injuries to receive immediate care. All processes and procedures were followed, and all affected animals received veterinary attention. One hundred fifty-nine animals received care with no loss of life.

The prompt consideration of this matter by the Texas Biomedical Research Institute was consistent with the philosophy of institutional self-regulation. Similarly, the actions taken to resolve the issue were appropriate. We appreciate being informed of this incident and find no cause for further action by this office.

The Texas Biomedical Research Institute (TBRI), in accordance with Assurance D16-00048 and PHS Policy IV.F.3., provides this report of an unanticipated inclement weather event resulting in a number of non life-threatening weather related injuries to our baboon colony. These animals are on the P51 Base Grant (OD011133-21) holding/colony protocol. This event was first reported to Dr. Brent Morse, OLAW via a zoom conference call by Diana Scorpio, D.V.M., Attending Director and Associate Director, Southwest National Primate Research Center and IACUC Office Staff.

Immediate corrective actions were taken to include providing additional supplemental heat and overnight observations. Staff provided continual care and observations to allow animals identified with weather related injuries to receive immediate care. All processes and procedures were followed and all animals received veterinary attention. After all animals had been assessed and treated the number concluded with 159 receiving care with no loss of life or significant impact. Commendations to our staff and their ability to manage a large breeding colony while under severe weather conditions that negatively impacted many areas in South Texas.
