Dear Dr. Norton,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your January 13, 2022 letter reporting an adverse event involving a research horse at the University of Florida. According to the information provided, OLAW understands that following an Institutional Animal Care and Use Committee- approved intestinal surgery, a horse experienced complications following anesthetic recovery. The animal repeatedly attempted to stand and when it did, the right hind fetlock became disarticulated and penetrated the skin.

The immediate action taken in response consisted of euthanizing the horse. No abnormalities were noted during the surgery or in the application of the anesthesia.

Based on its assessment of this explanation, OLAW concurs that the incident was an unexpected adverse event. As the study was not PHS-funded and there was no noncompliance identified, it was not necessary to report the matter to OLAW. While not exactly meeting the definition found in the examples of what not to report in NOT-OD-05-034, this unexpected negative outcome occurring during the provision of standard veterinary care could be matched to the following statement: "Examples of situations not normally required to be reported: animal death or illness from spontaneous disease when appropriate quarantine, preventive medical, surveillance, diagnostic, and therapeutic procedures were in place and followed." We recommend conferring with OLAW as to whether an incident qualifies for reporting or not. Thank you for informing OLAW about this matter.

Dear Dr. Wolff:

The University of Florida, in accordance with Assurance D16-00244 and PHS Policy IV.F.3., provides this report of an adverse event regarding accidental injury leading to euthanasia of a horse. A preliminary report was not sent to OLAW regarding this adverse event.

On December 7, 2021 a research horse underwent IACUC-approved intestinal surgery. The surgery went as planned with no intraoperative complications, but recovery from anesthesia was complicated by strong but uncoordinated attempts to stand. In the final attempt the horse stood with extreme difficulty and the right hind fetlock became disarticulated and penetrated the skin. The horse was immediately euthanized according to the approved protocol. The Attending Veterinarian was notified immediately. The anesthesia record was reviewed and there were no concerns regarding the documentation of care according to protocol and standard veterinary procedures for abdominal surgery in the horse.

The IACUC full committee voted on December 21, 2021 that this incident was an adverse event and was reportable through the IO to regulatory agencies.

This study is not funded by PHS.
