Dear Dr. Burg,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your July 28, 2021 final letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Georgia. A preliminary email report was provided on June 22, 2021. According to the information provided, OLAW understands on June 8, 2021, a researcher collected a volume of blood from mice that was over the approved amount on the protocol and two animals died. The study was PHS funded.

As a corrective measure, the principal investigator (PI) was required to develop and follow a written plan for maintaining compliance and meet with the IACUC to describe how compliance maintained will be accomplished. Additionally, the PI met with the Interim Intuitional Official, the College of Veterinary Medicine Dean and Associate Dean for Research and Graduate Affairs.

OLAW appreciates the prompt consideration of this matter by the University of Georgia which is consistent with the philosophy of institutional self-regulation. OLAW expects continuing post-approval monitoring to prevent recurrence of this non-compliance and potential associated animal welfare concerns. Based on the information provided, OLAW is satisfied that appropriate steps have been taken to investigate this incident and to attempt to prevent recurrence.

This work is covered by an IACUC approved protocol and funded by the NIH under grant number 75N93019C00052.

The remedial action plan was completed on July 21.

- The PI was to develop and follow a written plan for maintaining compliance within the laboratory.
  - This was completed on July 5.
- The PI was to meet with the IACUC to describe how he intends to maintain compliance within the laboratory.
  - This was completed on July 21.
- The PI was to meet with the Interim Institutional Official, the College of Veterinary Medicine Dean, and Associate Dean for Research and Graduate Affairs.
   This was completed on June 25.

At its scheduled meeting on July 21, the IACUC discussed the matter, determined that the response to the remedial action plan was adequate.

Dear Dr Morse,

I am writing to provide a preliminary report of a serious deviation from the PHS Policy that was identified on June 8, 2021. A researcher collected a volume of blood from mice that was more than what was approved on the protocol. Two of the mice died.

This work is covered by an IACUC approved protocol and funded by the NIH under contract number 75N93019C00052.

The IACUC discussed this event at its regularly scheduled June 16 meeting, as well as this lab's other recent non-compliance events with negative impacts on animals. The IACUC determined that action was required from the PI to demonstrate a plan to maintain compliance within the lab.

The following actions are required as the remedial action plan established to address the issue:

- The PI will develop, and follow, a written plan for maintaining compliance within the laboratory. A Compliance Sustainability Plan template, with suggested options for the PI and lab personnel actions, was provided. (Template provided June 22)
- 2. The PI will meet with the IACUC to describe how he intends to maintain compliance within his laboratory. (Anticipated July 21)



3. The PI will meet with the Interim Institutional Official, the College of Veterinary Medicine Dean and Associate Dean for Research and Graduate Affairs. (Scheduled for June 25)

The IACUC will be notified about any updates on the remedial plan, at its next scheduled meeting on July 21. Once the remedial action plan is complete, a full report with an update on corrective action progress will be forwarded to you.

In the interim, please contact me if you have any questions or if you require additional information.
