Dear Dr. Martinis,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of a June 15, 2021 letter, signed by Josh Gulley, IACUC Chair, reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Illinois at Urbana-Champaign. The letter supplements the information in the telephone prompt report on June 3, 2021. According to the information provided, OLAW understands that on May 12, 2021, the IACUC convened a meeting and voted unanimously to suspend all study protocols and associated activities for one principal investigator for a period of one year from May 19, 2021 until May 18, 2022 due to failure to maintain proper attention to, and oversight of, animal use activities in his laboratory and recurring noncompliance. The recent issue stemmed from his laboratory personnel performing experiments involving injection of transgenic constructs into fish eggs. Those eggs subsequently hatched, and the resulting fish were allowed to develop and were being maintained. These animal use activities were not described or approved previously under his active protocol and they also did not have required Institutional Biosafety protocols in place. The care and maintenance of the animals was transferred to the Division of Animal Resources (DAR) until the suspension has been lifted or a suitable alternative arrangement can be made. At the conclusion of the suspension, the PI will be under a probationary period of 3 years.

Based on the information provided, OLAW is satisfied that appropriate actions have been taken to investigate this incident and prevent recurrence. OLAW concurs that the incident warranted reporting. Please be sure to report the suspension of any PHS-funded protocol to the funding component. Also, as the Institutional Official, please sign or acknowledge all final reports to OLAW. We appreciate being informed of this matter and find no cause for further action by this office. Thank you.

Dear Dr. Morse:

I am writing to follow-up on our phone conversation from June 3, 2021 when I gave you a preliminary report of our Institutional Animal Care and Use Committee (IACUC)'s actions concerning a Principal Investigator at the University of Illinois, Urbana-Champaign named Justin S. Rhodes.

On May 12, 2021, the IACUC convened a meeting to discuss information about animal use activities that had been provided by Professor Rhodes in response to queries from reviewers who were evaluating a new protocol application. Professor Rhodes revelated that he and/or his laboratory personnel had performed experiments involving injection of transgenic constructs into fish eggs, these eggs subsequently hatched, and the resulting fish were allowed to develop and were being maintained. These animal use activities were not described or approved previously under his active protocol 18071 and they also did not have a required Institutional Biosafety protocols in place. This activity therefore represented a significant protocol deviation of a serious nature.

In its discussion of this unapproved animal use, the IACUC noted that Professor Rhodes was previously suspended from all animal use activities in June 2017 due to a repeated failure to address deviations and other issues for a study in mice, as well as a failure to engage effective safeguards to avoid future missteps. That suspension was lifted in September 2017. The IACUC noted the current incident represented a resumption of Professor Rhodes' failure to maintain proper attention to, and oversight of, animal use activities in your laboratory.

The IACUC voted unanimously to suspend all study protocols and associated activities for which Professor Rhodes serves as principal investigator for a period of one year from May 19, 2021 until May 18, 2022. The care and maintenance of the animals on Professor Rhodes' currently active protocols was transferred to the Division of Animal Resources (DAR) until the suspension has been lifted or a suitable alternative arrangement can be made. The IACUC also prohibited Professor Rhodes from engaging in animal use activities as personnel on protocols for which other University faculty serve as principal investigator.

At the conclusion of the suspension, Professor Rhodes will be under a probationary period of 3 years. A significant protocol deviation during this time will put Professor Rhodes at risk of a permanent ban from all animal use activities on the University of Illinois, Urbana-Champaign campus. The IACUC informed

Professor Rhodes that if he desired earlier reinstatement of his privileges to perform research with animals, that request must be made in writing after 6 months of the suspension (November 18, 2021).

Please note that the final decision to suspend Professor Rhodes was done in consultation with our Institutional Official (IO), Dr. Susan Martinis.
