- 1. Occupational Health and Safety: Representative from Employee/Health sent updates via email:
 - a. Two employee injuries related to NHPs. All protocols were followed, treatment initiated, and samples submitted for evaluation.

- b. Re-vamping the Health Questionnaire to more accurately capture information needed to enroll employees/students in appropriate health/safety surveillance programs. Recommend having new employee/students continue to submit the current form but pause sending out annual renewals. Animal exposure forms will continue to be updated annually.
- 2. Veterinary: Representative from CCR provided a report.
 - a. HVAC replacement project for **the environment**: Contractor will be on-site July 5th. Project projection time frame is 12 months.
 - b. Clinical Veterinarian position: A local veterinarian has applied for the position and is moving through the HR process.
- 3. Legal: Representative from Legal provided an update.
 - a. Cage Wash replacement paperwork moved through Legal and has been signed off. Moving to next phase in the procurement process.
