The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your June 11, 2021 letter in response to OLAW's June 11, 2021 request for information regarding an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at The University of Iowa. OLAW understands that all 13 mice detailed in the report were found dead in the cage which lead to the investigation. The agent that was administered was found to be the most likely cause of mortality however it was found to be used without toxicity by the supplier per published literature. The laboratory is working with veterinary staff to refine and evaluate further use of the agent in the lab's genetically modified animals.

OLAW appreciates the prompt consideration of this matter by The University of Iowa which is consistent with the philosophy of institutional self-regulation. Based on the information provided, OLAW is satisfied that appropriate steps have been taken to investigate this incident and to attempt to prevent recurrence. OLAW expects continuing post-approval monitoring to prevent recurrence of this non-compliance and potential associated animal welfare concern. Dear Dr., Lukovsky-Akhsanov:

This letter is to provide additional information, as requested, for case UI 3021-4S.

The original report indicated that four cages (13 mice) were involved in the non-compliance. Your interim response letter dated June 11, 2021 requests information on the disposition of the "remaining four animals." However, no information on the disposition of any of the 13 mice was detailed in our report. All mice were found dead in the cage which led to the investigation of the event and determination of this non-compliance. The agent that was injected is the most likely cause. It was reviewed and found to have been used successfully, without toxicity, by the supplier (i.e., found in published literature). It appears the agent caused toxicity in this lab's genetically modified mice. The lab is working closely with veterinary staff to refine and evaluate further use of this agent in their particular animals.

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your May 14, 2021 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Iowa. According to the information provided, OLAW understands that on April 10, 2021, a lab member injected 13 mice with unapproved treatment agents however the agents were approved on another one of the lab's approved protocols. The study was PHS funded.

As a corrective measure, the IACUC Training and Compliance Manager met with the lab member to provide retraining and discussed the matter with the Principal Investigator. An amendment to the protocol was submitted and is under IACUC review.

OLAW appreciates the prompt consideration of this matter by the University of Iowa which is consistent with the philosophy of institutional self-regulation. Based on the information provided, OLAW requests the following information:

 Please provide information regarding direct animal welfare concerns related to noncompliance including any required medical interventions (e.g. treatment, euthanasia) and animal disposition for the remaining four animals.

Dear Dr. Wolff:

This letter is to report an incident involving mice. The University of Iowa PHS Assurance Number is D16-00009 (A3021-01). The grant number affected is CA099908.

April 10, 2021: A lab member was found to have injected mice with unapproved tumor treatment agents (four cages with 13 total mice), resulting in an unapproved procedure. The agents are approved on another of the lab's approved Animal Protocols.

The IACUC Office was promptly notified. The IACUC Training and Compliance Manager met with the lab member to provide retraining. S/he also discussed the matter with the PI and recommendations were made to the PI to amend the protocol, or to otherwise ensure proper transfer of mice to the appropriate protocol. The amendment has been submitted and is under IACUC review.

May 12, 2021: The IACUC members discussed the incident at a convened meeting and voted to report to the appropriate agencies.
