The University of Kansas (KU), in accordance with Assurance D16-22 (A3339-1) and PHS Policy IV.F.3., provides this follow-up report regarding an incident of noncompliance on a subaward to University of Michigan (UM) from KU NIH award 1-RO1-EY029489, *Precisely removing microvessels by photo-mediated ultrasound therapy*. On August 30, 2018, KU and UM entered into an interinstitutional agreement for KU to rely on UM Assurance D16-00072 (A3114-01) for oversight of animal care and use conducted on the subaward at UM. As the prime recipient of the NIH award, KU is providing this follow-up report to supplement reports made by UM directly to OLAW on October 6, 2021 and November 15, 2021. The OLAW-assigned case number for the incident is A3114-4Q.

On October 12, 2022, UM reported the incident to KU and noted that it had made all required notifications to federal agencies. On December 14, 2021, UM notified KU that the protocol suspension had been lifted. UM also provided copies of the relevant sections of IACUC meeting minutes regarding the case and copies of the protocol approval letter and the reports to OLAW. KU requested of UM whether during the period of suspension any animal care fees

had been charged to the subaward. On January 28, 2022, UM confirmed that no animal expenses had been charged to the subaward during the protocol suspension. KU determined that the period of suspension did not impact performance on the award and that the incident did not involve non-compliance with the award terms and conditions.
