Dear Dr. Cunningham,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your December 9, 2021 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Michigan. This letter had not been preceded by a preliminary report to OLAW.

According to the information provided, this Office understands that the University of Michigan Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to: the conduct of animal activities without prior IACUC review and approval; lack of appropriate veterinary oversight; failure to adhere to approved humane endpoints; and failure to follow veterinary directives. The final report states the IACUC was notified that animal activities were performed involving 6 mice, and these procedures were approved on a different investigator's IACUC protocol. The animals were kept in the investigator's lab space >24h without IACUC approval and were not provided adequate veterinary care. It is stated a separate group of 5 mice were not provided topical ointment for the entire duration of the veterinary orders.

In response, the IACUC voted to suspend the Principal Investigator's protocol and the matter was discussed on December 6, 2021. It is noted the protocol is supported by NIH funding and the University of Michigan. The committee determined the incident was not a programmatic failure and requires the following actions from the Principal Investigator (PI):

- A complete re-review of the protocol by the PI and a Faculty Veterinarian.
- A meeting with the PI, the lab staff, the IACUC Chair, and the Attending Veterinarian.
- The development of a corrective action plan (to be presented by the PI to the IACUC) to include
  the training and mentoring of new and current staff, a plan for the PI's oversight of all animal
  activities, and procedures for ensuring compliance with applicable IACUC policies, guidelines,
  and SOPs, adherence to the IACUC-approved protocol.
- When the IACUC protocol is reinstated and animal activities commence, the investigator's
  program will remain on probation until further notice, during which time the PI is required to
  submit bi-monthly reports to the IACUC on the status of their research program (e.g., what
  animal activities were conducted, the clinical status of the animals, veterinary communications).

Based on its assessment of this explanation, OLAW understands that the University of Michigan has implemented appropriate measures to correct and prevent recurrences of these problems and is now compliant with provisions of the PHS Policy.

We appreciate being informed of these matters and find no cause for further action by this Office.

Dear Dr. Morse:

The University of Michigan, in accordance with Assurance D16-00072 and PHS Policy IV.F.3., provides this report of non-compliance associated with a Principal Investigator's (PI) animal study protocol, titled "Inflammation, the gut microbiome, and colon carcinogenesis." Animal activities involving approximately six (6) mice were conducted (a) without appropriate IACUC approval (the procedures conducted were approved on a different PIs IACUC protocol); (b) without appropriate veterinary oversight (the animals were kept in the PIs lab space for more than 24 hours, without IACUC approval, and were not provided adequate veterinary care); and (c) without adhering to approved humane endpoints. Additionally, in a separate group of approximately five (5) mice, animals were not provided a topical ointment for the entire duration of the veterinary orders.

The IACUC considered this matter in accordance with the IACUCs *Policy on Investigating Noncompliance and Animal Welfare Concerns* and voted to suspend the Principal Investigator's (PIs) IACUC protocol. This matter was discussed by the IACUC on December 6, 2021.

The suspended protocol involves research funding provided through the National Institutes of Health (grant number R01 DK122812-01) and the University of Michigan. NIH funding used to support activities that were not approved by the IACUC were negligible and, once suspended, no funds are being spent on animal activities. Accordingly, the NIH funding component was not notified of the situation.

The IACUC determined the concerns to be isolated to this laboratory and not a programmatic failure. In addition to the protocol suspension, the IACUC requires:

- A complete re-review of the protocol by the PI and a Faculty Veterinarian;
- A meeting with the PI, the lab staff, the IACUC Chair, and the Attending Veterinarian;
- The development of a corrective action plan (to be presented by the PI to the IACUC) to include the
  training and mentoring of new and current staff, a plan for the PIs oversight of all animal activities, and
  procedures for ensuring compliance with applicable IACUC policies, guidelines, and SOPs, adherence to
  the IACUC approved protocol; and
- When the IACUC protocol is reinstated and animal activities commence, the PIs program will remain on
  probation until further notice, during which time the PI is required to submit bimonthly reports to the
  IACUC on the status of their research program (e.g., what animal activities were conducted, the clinical
  status of the animals, veterinary communications).

The PIs protocol suspension will not be lifted until the IACUC is satisfied with the corrective action measures.
