Dear Ms. Caudill,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your October 11, 2021 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals within the animal care and use program at Yale University. Your letter supplemented the information contained in an initial email report to this office on June 15, 2021. According to the information provided, OLAW understands that 138 mice did not receive perioperative analgesia as approved in the protocol. The responsible laboratory member changed the surgical analgesic regimen from pre-emptive buprenorphine to a pre-emptive nonsteroidal anti-inflammatory drug without consulting the principal investigator (PI). The laboratory member also did not administer postoperative analgesia or maintain postoperative records for survival surgeries performed. The PI self-reported the incident which was discovered after review of analgesia use and surgery records. No animal health or welfare concerns were reported associated with the surgical procedures. The mice involved were supported by PHS funds.

Corrective and preventive measures included retraining of all laboratory personnel involved in surgical procedures, including the PI. The responsible laboratory member was also counseled regarding the seriousness of the noncompliance issues. The noncompliant laboratory and responsible laboratory member are subject to enhanced monitoring by the university's Office of Animal Research Support (OARS). The responsible laboratory member has transferred to a laboratory that does not conduct surgical procedures, but if surgery is ever added to the current protocol, a meeting will be held with the PI, laboratory member, and representatives from the veterinary and OARS teams to reinforce the expectations of the Institutional Animal Care and Use Committee (IACUC) when conducting surgery. In accordance with university procedure, this incident will be reported to the appropriate NIH Institute/Center.

OLAW appreciates the consideration of this matter by Yale University, which was consistent with the philosophy of institutional self-regulation. Based on the information provided, OLAW is satisfied that appropriate actions have been taken to investigate this incident and prevent recurrence. We appreciate being informed of this matter and find no cause for further action by this office.

Dear Dr. Morse:

In accordance with the Public Health Service Policy and Yale University's Animal Welfare Assurance (#D16-00146), I am writing to report the fact-finding results of an animal welfare-related incident self-reported by a Principal Investigator (PI).

On April 26, 2021, a PI self-reported to the Office of Animal Research Support (OARS) that an unknown number of mice that underwent surgery had not received analgesics as approved in the protocol. The need to order additional anesthetic agent for upcoming surgeries led to the review of analgesic use and surgery records.

During OARS' fact-finding activity with the PI and lab personnel, the following information was relayed:

- During the summer of 2020, a lab member expressed a concern regarding the use of isoflurane anesthesia, consulted with a veterinarian, and the protocol was modified and approved to use ketamine/xylazine for surgical procedures.
- Subsequent to this change, without notifying the PI, the lab member discontinued the use of pre-emptive buprenorphine due to the longer recovery time when using ketamine/xylazine.
- During the period of August to December 2020, the lab member did not administer postoperative analgesia or maintain post-operative records for survival surgeries performed.
 - Controlled substance logs and vial stocks were reviewed, and it was confirmed this information was not included.
 - Surgery records reviewed by OARS indicated that nonsteroidal antiinflammatory drugs were pre-emptively administered instead.
- There were no animal health or welfare concerns reported by YARC or VCS during this time and related to this protocol.
- During the months of November and December 2020, the same lab member began training a new student to cover for the lab member's anticipated leave of

absence. Training was abbreviated due to an earlier-than-expected departure and resignation of the lab member. The lab did not request addition training from OARS.

- During this period of time a total of 235 surgeries were performed on 138 mice.
- Effective June 2021, the lab member took a position working in another laboratory and on an unrelated protocol.

In May 2021, all current lab personnel involved in surgical procedures, including the PI, were re-trained by OARS. The IACUC reviewed the details of the incidents at the May and June 2021 meetings. The IACUC Chair and OARS leadership met with the PI. In a separate meeting, the OARS leadership met with the lab member to emphasize the seriousness of the non-compliance issues described above.

In addition, OARS is conducting enhanced monitoring of the non-compliant laboratory and of the responsible lab member in the new laboratory. It should be noted that the lab member's current laboratory does not conduct surgery, but if surgery is ever added to the current protocol, a meeting will be held with the PI, lab member, and representatives from the veterinary and OARS teams to reinforce the IACUC's expectations when conducting surgery. Throughout the investigation, the PI was very cooperative and contrite that something so serious could have happened in their lab.
