Dear Dr. Flotte,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your June 15, 2021 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Massachusetts Medical School. According to the information provided, OLAW understands that due to the expiration of a protocol, 104 mice were moved to the central holding protocol. Breeding is not approved under the holding protocol but the mice had not been separated and breeding continued. A laboratory member separated the breeders although handling of the animals by the researcher had not been approved while on the holding protocol.

The corrective actions consisted of notifying the Principal Investigator and staff that they are not permitted to handle animals on the holding protocol. The Department of Animal Medicine staff was retrained by the Attending Veterinarian to ensure that breeders are separated while on the holding protocol.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy.

Dear members of the Division of Compliance Oversight,

The University of Massachusetts Medical School, in accordance with Assurance #D16-00196 (A3306-01) provides this report of protocol noncompliance for your consideration, associated with IACUC protocol Legacy 1910-18.

IACUC protocol Legacy 1910-18 is an IACUC-approved blanket holding protocol for which the UMMS Attending Veterinarian is the Pl of. On March 2, 2021, an experimental protocol lapsed, and 104 mice were transferred to the blanket holding protocol. Breeding is not an approved activity on the blanket holding protocol, and it is standard practice for Department of Animal Medicine staff to separate breeders while being held. The breeding mice were inadvertently not separated upon transfer and therefore breeding continued. A member of the laboratory noticed that breeding cages had not been separated and did so on behalf of Department of Animal Medicine. This researcher was not approved to handle animals on this protocol.

The Department of Animal Medicine husbandry supervisor immediately notified research personnel (and the PI) that they are prohibited from handling animals while on a holding protocol. The remaining breeding cages were immediately separated by Animal Medicine staff.

This incident was reported to the IACUC on 3/29/2021 and discussed by full committee on 4/26/2021. As a corrective action, the Attending Veterinarian met with Department of Animal Medicine staff to discuss the specific reason for this occurrence and retrained on procedures for separating breeding animals while on a holding protocol to prevent this in the future. The IACUC required no further actions.

NIH funds were not used to support the activities described in this report.
