Changes to the program of animal care and use

Designated Member Review change from assurance statement

Our institution is moving to a cloud-based electronic IACUC protocol platform in 2022. This new system will change how both protocols and amendments are submitted and how the DMRs review them. To anticipate these changes, we have made changes in the time to review protocols and amendments for DMRs. All members still have three business days to ask questions, comment or call for full committee review. The change is that all the chair-assigned DMRs, regardless of primary or secondary, as well as the veterinarian now have the same review time of five business days. The IACUC administrative staff will then compile the list of comments to send to the PI. This change is in anticipation of the online system having the review open to all DMRs at once and the IACUC office being the one who will search for duplicates before sending to the PI.

Addition of new facility

We have added the School of Veterinary Medicine (SVM) in Amarillo, Texas to our animal program. This new unit will use animals in both research and veterinary teaching. Regulatory oversight falls under the Texas Tech University IACUC office (A3629-01). SVM adheres to all items outlined in the assurance statement; the same protocol review processes, training requirements, and web-based risk assessment and evaluation, but the local occupational medicine provider is Concentra. SVM is included in semi-annual inspections of facilities and program review. The first facilities were approved August 2021, but first semi-annual inspections were conducted outside of this reporting period.
