Dear Mr. Henderson,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your January 27, 2022 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Rhode Island Hospital, following up on an initial report on December 8, 2021. According to the information provided, OLAW understands that a pig developed an infection at a surgical incision site and that the veterinary staff directed the laboratory staff to continue treatments over the weekend. Due to illness of the laboratory staffer, the treatment was not done. Also, post-operative monitoring was not appropriately documented by the laboratory staff.

The corrective actions consisted of retraining the laboratory staff on post-operative monitoring, adequate documentation, and the requirement for following veterinary directives. The weekend schedule will now be shared with the veterinarians, Principal Investigator, and laboratory staff. The monitoring form was updated and procedures will be performed earlier in the week to minimize weekend activities.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy. Unless informed to the contrary, OLAW assumes the pig involved recovered as expected. Thank you for keeping OLAW apprised on this matter.

Dear Dr. Morse,

I am writing to provide final follow-up to a report of non-compliance with PHS Policy on the Humane Care and Use of Laboratory Animals that was submitted by us on December 8, 2021. The work is supported in part with an NIH grant (1R01HL128831).

In brief, a single pig developed an infection along a surgical incision, which was being treated by veterinary staff. The lab staff was directed to continue treatment through the weekend of November 27-28, 2021, but treatment was not performed. In reviewing the animal care documents as part of this matter, the veterinarian discovered additional irregularities in the post-operative monitoring records. In accordance with institutional policy, an investigative subcommittee of the IACUC was formed to look into the matter.

Findings

- The veterinarian directed research staff to clean the surgical incision over the weekend, but this was not done due to illness of the assigned lab staff member.
- Research staff did not appropriately document post-operative monitoring.

Corrective action

- The veterinarian re-trained the research group on monitoring, documentation, and the expectations regarding compliance with veterinary directives.
- The lab and veterinarians developed a plan in which the weekend schedule will be sent to veterinary services, the PI, and the lab members each week, to ensure accountability and appropriate oversight.
- The protocol-specific post-op monitoring form was updated to facilitate accurate completion and promote adherence the IACUC-approved monitoring plan.

Future errors in weekend monitoring compliance may result in a loss of animal care
privileges for the responsible individuals, and/or a mandate that surgeries be done on
earlier in the week to avoid weekend post-op monitoring requirements.

The incident was reviewed at the regularly scheduled January 26th meeting of the full IACUC, at which time the IACUC voted to accept the corrective action plan.

Good morning,

I would like to provide preliminary notification regarding an allegation of non-compliance within our institution. In brief, an animal developed an infection along a surgical incision. This was being treated by veterinary staff. The lab staff were directed to continue treatment through the weekend, but this was not done due to illness in the staff member assigned to come in to take care of the animal.

In reviewing the documents, the vet discovered other irregularities in the post op monitoring records.

An investigative sub-committee of the IACUC has been formed to look into the matter and the vet has a meeting with the lab staff next week.

We do not anticipate that the investigation will be complete in time for the December IACUC meeting, so we will not have a final report to you until the end of January.
