# Description of Changes to the Program of Animal Care and Use University of Massachusetts Chan Medical School D16-00196 (A3306-01) October 1, 2020-September 30, 2021 Reporting Period

- University of Massachusetts Medical School has changed its name to University of Massachusetts Chan Medical School (UMCMS). The Assurance has been updated throughout to reflect this change.
- 2. Updated Section III.d.2. The inspection frequency has been modified for all locations that UMCMS IACUC has oversight of (UMCMS, UMass Memorial Medical Center and MassBiologics). This change only affects study areas located outside of a core animal facility or satellite facility where non-surgical manipulations occur on animals. For these study areas, inspections will typically occur once per year, instead of semi-annually.

All other locations will be inspected once every 6 months, including core animal facilities (including buildings, rooms, areas, enclosures, or vehicles, including satellite facilities, used for animal confinement, transport, maintenance, breeding, or experiments inclusive of surgical manipulation), areas outside of a core animal facility where surgical manipulations occur on animals, and all animal facilities and study areas involving use of AWA-regulated species. "Study area" is any building, room, area, enclosure, or other containment outside or a core facility or centrally designated or managed area in which animals are housed for more than 12 hours.

**3.** Change in IACUC Membership: The roster has been updated to reflect changes in IACUC membership. Two members (scientist) have stepped down.
