The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your August 30, 2021 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the Auburn University following up on an initial June 25, 2021 notification by email.

According to the information provided, this Office understands that the Auburn University Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to: the conduct of unapproved animal-related activities without prior IACUC review and approval. The final report states on June 24, 2021, the IACUC was notified that a principal investigator (PI) possibly used Avertin without prior IACUC approval when conducting a research procedure. In response, a subcommittee was formed to investigate the matter. The PI acknowledged that Avertin was used as an anesthetic agent in two mice without IACUC approval. In response, the IACUC issued a memorandum to the PI directing the immediate termination of the use of Avertin. Per the report, no adverse events were known to have occurred in these animals. The investigative results from the subcommittee were presented to the IACUC, and on July 15, 2021, the IACUC voted to implement the following actions:

- Suspend the PI from conducting any animal activities at Auburn University for a period of no less than nine months.
- Suspend the PI's IACUC protocols and transfer the animals to a holding protocol not administered by the PI.
- Require successful training on professionalism and integrity in research programs.
- Require successful retraining by completion of required IACUC training modules (online).
- Require successful retraining on the use of the primary rodent vivarium on the Auburn University campus.
- Require a post-assessment interview with members of the IACUC.

It is understood the PI submitted an appeal letter and the IACUC voted to decrease the suspension duration to no less than 6mo while maintaining the other requirements from the IACUC decision of July 15, 2021.

It is noted that this research is supported by PHS funding. Where applicable, please note that the PHS funding component must be notified directly of any suspension or termination of HHS (PHS) supported research. Based on its assessment of this explanation, OLAW understands that the Auburn University has implemented appropriate measures to correct and prevent recurrences of these problems and is now compliant with provisions of the PHS Policy.

We appreciate being informed of these matters and find no cause for further action by this Office.

We are providing a final report of noncompliance at Auburn University. The preliminary report was sent via email on June 25, 2021. The project is funded by NIH Grant 5R01HL125279-05.

On June 24, 2021, the IACUC received a report that Avertin had potentially been used without prior IACUC approval during conduct of a research procedure. An IACUC subcommittee was appointed to investigate the situation. The principal investigator (PI) confirmed that Avertin had been administered as an anesthetic agent to two mice without IACUC approval. The IACUC issued a memorandum to the PI directing the immediate cessation of use of Avertin. No adverse events are known to have occurred in these animals. After the subcommittee presented its findings to the committee, the IACUC discussed the Incident.

At the IACUC meeting on July 15, 2021, the IACUC voted to:

- 1) Suspend the PI from conducting any animal activities at Auburn University for a period of no less than nine months
- Suspend the PI's IACUC protocols and transfer the animals to a holding protocol not administered by the PI
- 3) Require successful training on professionalism and integrity in research programs
- Require successful retraining by completion of required IACUC training modules (online)
- Require successful retraining on the use of the primary rodent vivarium on the Auburn University campus
- 6) Require a post-assessment interview with members of the IACUC


After consultation with the Institutional Official, a letter indicating the above actions was sent to the PI.

An appeal letter was submitted to the IACUC by the PI on July 29, 2021. The letter was discussed at the IACUC meeting on August 5, 2021. The IACUC voted to reduce the suspension duration to no less than six months but maintain the other requirements from the IACUC decision of July 15, 2021.

We are providing a preliminary report of noncompliance at Auburn University.

Currently we are aware of the following: On June 24, 2021, the IACUC received a report that Avertin had potentially been used without prior IACUC approval during conduct of a research procedure. On June 25th, the principal investigator (PI) confirmed that Avertin had been administered as an anesthetic agent to two mice without IACUC approval. No adverse events are known to have occurred in these animals.

The IACUC issued a memorandum to the PI directing that the unapproved use of Avertin must stop immediately.

The IACUC has formed a subcommittee to gather and review all details surrounding this situation. Since our investigation of this incident is in its initial stages, we are still determining if there is an external funding component. If a funding component is found to be associated with this activity, we will report our findings to all applicable parties.

Once the investigation is completed, the subcommittee report will be presented to and discussed by the IACUC during full committee review and then a summary of findings with declaration of corrective actions taken will be reported to OLAW.
